Tim Merrill, General Manager, reported:

- For the month of January 2026, Simulcast (Parimutuel) wagering as defined by the Kansas Racing and Gaming Commission produced a total takeout of \$58,363.51.
- Historical Horse Racing Machines recorded a total handle of \$29,446,533.88.
- Patron count for the month of January was 59,396. On the weekend of Friday, the 23rd there was a snowstorm that negatively impacted patronage

- Commissioner Turnquist asked General Manager Merrill how things were going in general at the facility. General Manager Merrill responded that he believes the facility is meeting expectations. The facility has been open for forty-five days. The first direct mail offers were sent out at the end of January for February redemption. There have been 4,000 redemptions so far. The database sits at about 22,000 people. Food and beverage continue to exceed expectation at both the honkytonk and Golden Circle. Visitation has been great, 5,000-6,000 people Friday/Saturdays, about 4,000 people on Sundays, and like the rest of the market visitation drops off mid-week. General Manager Merrill said that he expects that most of these builds take 12-18 months to hit maturity; you get your legs underneath you at about six months and really start your growth pattern at twelve months. The facility is where it is supposed to be and that there are no red flags. There is a lot of upcoming programming.
- Chairman Moses asked how the Super Bowl event was. General Manager Merrill said that it went really well. There were 200 people on the third floor, in Golden Circle, and 150 people on the first floor in Gilley's. Chairman Moses asked if the 200 people was the facility's capacity. General Manager Merrill said that capacity is 300 but there are only 200 available reservations.
- Chairman Moses asked if there was a way to track if the patron count included repeat patrons. General Manager Merrill said 1.5 visits a month through the first 65-days of people who have signed up. There is

no data for people who have not signed up. About 10% are coming three or more times, about 30% are visiting twice, the rest are at one or one and a half.

- Chairman Moses asked if the facility has been able to track the number of minors who have been on the gaming floor. General Manager Merrill said that the facility has been tracking that, but he did not have those numbers with him. Further explaining that the number of minors of the gaming floor has been less than what the general manager anticipated. General Manager Merrill said that it may be that 40 minors stepped on to the gaming floor and that there were four that participated in gaming, two of which were unintentional.

Jeff Longwell, Chairman of Wichita GC Charities, reported:

- Currently there is about \$10,000 in the Gilley's Cares checking account. Revenue is coming from patron donating the odd cents on their machines. The charity board has an opportunity to receive sponsorship dollars.
- Chairman Moses asked if the board was still the same number. Chairman Longwell confirmed it is still a five-member board with all positions being filled.

Director of Electronic Security, Licensing, and Backgrounds Roger Bailey presented the staff agenda memorandum on the requested waiver to amend K.A.R. 112-110 and recommended that the commission approve the amendment.

Commissioner Jones (Turnquist) moved to approve the requested waiver to amend K.A.R. 112-110. Motion passed 5-0.

PUBLIC COMMENTS
(H.)

Kurt Eck, President of Kansas Quarter Horse Racing Association, introduced himself to the commission. Mr. Eck asked the commission to update the regulations around the Kansas breeder's development fund and the fair fund regulations. In particular on the Kansas breeder's development fund, there are several issues that the association's members consider to be a priority to getting updated. Mr. Eck shared that he thinks that it would be very valuable if a board of directors was formed on the industry side of things so that there can be better communication with KRGC staff to try to get the regulations that the association feels is priority to updated sooner rather than later. For example, one of the changes in the law is the removal that Kansas-bred purse supplement awards only be paid to horses that come first, second, or third and regulation still reflects the old law. If possible, the association would like to see that regulation changed before the race meets this Fall so that more of the Kansas-bred funds can be shared with more people racing in Kansas. Mr. Eck said that

is just one example. Currently things are unorganized and things are just being thrown at agency staff, if we can try to organize the industry a little bit better and have a better conduit to the agency and get some of these things updated. Mr. Eck shared he is looking forward to a restart of live racing in Kansas.

- Chairman Moses asked if Mr. Eck was currently working with staff to match regulations with updated statute. Mr. Eck confirmed he has lots of conversations with staff and understands that staff has been focused on getting Gilley's operational.
- Commissioner Turnquist asked what the prospects of getting the board of directors together with the horse groups. Mr. Eck explained that he believes his group is ready to put their side of it together. Further explaining that there are two main breed groups, the quarter horse and thoroughbred, and that the two groups will need to work together to form the board.

STAFF REPORTS (I.1. and I.2.)

Garrett Rogers, Paralegal, reported on both the Voluntary Exclusion Program and Sports Wagering Exclusion Program statistics for the month of January 2026.

- Chairman Moses asked if Mr. Rogers had a way to track Gilley's exclusions. Mr. Rogers responded that at this time the data is not shared with the agency, in the future Gilley's may decide to share that data with KRGK.

Government Relations Manager Randy Evans reported:

- There is a proposed amendment to the Kansas Clean Air Act that would prohibit smoking from gaming facilities and racetrack gaming facilities. This bill was introduced last year and got one hearing. It was introduced this year in both the House and Senate. There was a hearing scheduled last week but was cancelled the next day. There has not been a hearing on that bill.
 - Commissioner Fleming asked when the turn-around deadline was. Mr. Evans responded that he believes it is February 23rd. Commissioner Fleming asked if Mr. Evans thought the bill was going anywhere. Mr. Evans said probably not.
- There is a Senate bill that would change the point at which a slot machine is considered an antique. Currently only machines manufactured prior to 1950 are considered antique. The change would define any machine manufactured over 50-years ago as antique. The bill is in the Fed and State Committee and has not had a hearing yet.
 - Chairman Moses asked what impacts this legislation could have on the agency. General Counsel Bain responded that if the machine is not an antique it would be a crime to possess. Chairman Moses asked if the agency has taken a position on the legislation. Mr. Evans said it has not.

- SB 469 would prohibit law enforcement from wearing face coverings. This pertains to KRGK because if the bill were to pass KRGK would have to have a publicly posted written policy. There are many exceptions to the prohibition. The bill has not had a hearing yet.
- SB 492 would require a law enforcement agency to disclose record of criminal conduct of a previously employed law enforcement officer if that officer is applying for a position with another law enforcement agency. The legislation was introduced by a lobbyist for KPOA, the Sheriff's Association, and the Chiefs of Police Association. Mr. Evans said that he assumes that this is precipitating from a law enforcement agency that has chosen not to share that information with another law enforcement agency. There has not yet been a hearing.
 - Chairman Moses asked what the definition of criminal conduct was and whether it required a conviction. Mr. Evans said that he would need to review the bill and follow up with the commissioners. Mr. Evans clarified that the legislation would also require the reporting of any action that would rise to licensing or certification sanctions. Chairman Moses asked if the legislation says who determines that. Mr. Evans explained that the Commission on Peace Officers' Standards and Training are referenced within the bill but that he was not sure if they made the determination.
 - Commissioner Haag asked if the employer receives immunity for the disclosure. Mr. Evans confirmed that provision was in the legislation. The applicant is required to file a release and if the applicant refuses, the hiring agency shall not hire the applicant.
- HB 427 would allow the Senate and House to have a fiscal integrity auditor available full-time. In the first hearing, there were concerns that determinations on an agency's budget are being disregarded by the agency in question and that the legislature had no way of knowing this until next year when the agency comes before the legislature again. This auditor would allow the legislature to access the SMART system and the state's payroll system.
 - Chairman Moses asked if there was a fiscal impact statement published. Mr. Evans said there was not.
 - Commissioner Fleming asked who was required to have the auditor. Mr. Evans confirmed that there would be two auditors, one for the House and Senate, and that each auditor would review every agency.
- SB 502, which KRGK requested be introduced last week, ratifies KRGK's permanent sports wagering regulations. HB 2468, passed last year, requires agency regulations would cost the industry more than \$1 million in a five-year period be ratified by the legislature. There has been no hearing on SB 502.

- Chairman Moses asked what happens if there is not a hearing on the bill. Mr. Evans responded that the regulations would remain temporary.
- Commissioner Turnquist asked which committee the legislation was introduced into. Mr. Evans responded that it was Fed and State. Commissioner Turnquist noted that he believed that was an exempt committee so the agency would have more time to work on it. Mr. Evans confirmed that was accurate.
- In January the legislature confirmed the appointments of Commissioner Haag and Commissioner Jones.
 - Chairman Moses congratulated both commissioners.

Director of Administration, Audit, and Finance Brandi White reported:

- That the Gilley's revenue report appears vastly different than those of the KELA facilities and that is because the tax at the KELA facilities is determined on net gaming revenue, whereas the tax under the parimutuel act is figured on the total amount wagered.
- In January there was no transfer of funds from the State Racing Fund. In February, there has not been a final determination made. When transfers do happen, the Horse Breeding Development Fund will receive 30% of the HHR tax, the transfer to the County Fair Benefit Fund will be 70% of the HHR tax and one-third of the simulcast tax revenue, the transfer to the State Gaming Revenue Fund for 100% of race days fees and two-thirds of the simulcast tax.
- Chairman Moses asked that Director White to remind the commissioners of the key differences between what is done by the Lottery does with KELA facility revenue versus what will be done with the parimutuel revenue, clarifying that he recalls an additional step to reporting the revenue. Director White said that the reporting of the funds is generally similar but how the funds are dispersed is different. Director White said that she believes that the KELA facility tax revenue goes into the Expanded Lottery Revenue Fund and the first \$50 million is divided specifically by statute and beyond that those monies ultimately end up in the State General Fund.
- The KRGC budget has made it through both House Committee on Appropriations and Senate Committee on Ways and Means. In the House the \$100,000 enhancement request for capital outlay at Gilley's was removed, in the Senate it remained. KRGC staff will now be in consensus meetings. Director White reminded the commissioners that the agency is a no-limit fee fund, so that the agency does not impede industry or business growth, and that the agency has the authority to spend those funds.
 - Chairman Moses asked if there was a reason given by the House for the removal. Director White explained that they stripped it

from the bill too. Part of the reason was the House said if the agency has already made the expenditure why are you asking for it now. Director White explained that it is part of the budget process, you come back with a new budget and request new funds. Director White said that the House is trying to cut expenses this year and that it was one of the items they cut. Commissioner Haag commented that if she understands correctly because KRGC is a no-limit fee fund this removal would not impact the State General Fund. Director White confirmed that was accurate.

Executive Director Brownlee reported:

- Congratulations on Kurt Eck on his new position.
- The conference room we generally meet in is being renovated through March. This allowed a good opportunity to visit the new Docking State Office Building and utilize the conference rooms available to state agencies.
- The American Gaming Association's state of the states report for 2025 has recently been released. There are 537 tribal casinos in 29 states. There are 492 commercial casinos in 27 states. Both exist in Kansas. Commercial gaming increased 7.5% over prior year. Amounting to \$72 billion in commercial gaming revenue, adding in tribal casino revenue brings the total revenue to \$115 billion. Oklahoma has the most tribal casinos of any state with 141. The top five commercial gaming markets in 2025 were: Las Vegas, Atlantic City, Chicago, Washington D.C. Baltimore area, and New York. The St. Louis area ranked 9th in the country. Black Hawk Colorado area ranked 12th, and the Kansas City area ranked 16th. Internet gaming has been approved in eight states and has produced \$8.4 billion in gaming revenue. Pennsylvania is the largest i-gaming state. Currently, Kansas does not have i-gaming. Commercial sports wagering brought in \$13.8 billion and New York was the highest commercial sports wagering revenue producing state. Kansas gaming dollars were up 7.4% over prior year. Neighboring states did not perform as well, Arkansas was up 4.9%, Colorado was up 7.1%, Oklahoma was up 1%, Iowa was down 1.7%, Missouri was down 2.1%. Nebraska was an outlier with a year-to-year gaming revenue increase of 63%, but that is attributed to the opening of recent racinos.
 - Chairman Moses asked if there as been any interest in allowing i-gaming in Kansas. Executive Director Brownlee explained that there has been interest in that, but that has been on the Lottery side of things. Both houses in the legislature have not had a lot of interest in i-gaming. The Lottery has wanted i-lottery in conjunction with i-gaming and has tried for several years to get

both passed but with little progress. This last year, the Lottery came up with a new interpretation of the statute that allows them to conduct i-lottery without legislative approval and began those efforts. Executive Director Brownlee said that he anticipated that there would be some pushbacks on that but has not heard any this year. The Lottery does currently conduct i-lottery but not i-gaming. Chairman Moses commented that he is interested to see if there is an increase in lottery revenue or if patrons just move from purchasing lottery tickets in-person to online. Executive Director Brownlee noted that in other jurisdictions where i-lottery has been implemented it has been very successful.

- Director of Gambling DJ Lopez was not available this month, so Executive Director Brownlee did not have a detailed report regarding live horse racing. Director Lopez has been attending meetings with horse owners and the Greenwood County fair board. A more detailed report will be available next month. KRGC understands that a number of the regulations need to be adjusted. KRGC has purposefully tried to avoid getting into the thick of changing regulations. As commissioners know KRGC has been working to get the sports wagering regulations through the state's approval process for multiple years. With the interest of live horse racing starting this fall hopefully. KRGC does not want that start-up to be impeded by the processing of regulations. Unfortunately, when the HHR legislation was passed some of the language conflicts with the old parimutuel racing regulations. Those are mainly the things KRGC needs to work through. However, since racing stopped in 2008 the industry has changed a lot, so there are things that need to get updated. As Mr. Eck stated there have been a number of conversations with the horse groups in Kansas. KRGC plans to continue that and anticipates communicating and working with them to get these regulations where they need to be. KRGC wants to avoid the regulations interfering with the start up of racing this fall, if that is going to be available next fall.
 - Commissioner Haag asked if temporary regulations take the same amount of time to go through the state's approval process. Executive Director Brownlee explained that temporary regulations can be set up quicker but historically, on the KELA side of things, KRGC has not had the authority to use that option. General Counsel Bain noted that the temporary regulation process is quicker, but it is still not quick. Further noting that the state has purchased some technology that should streamline the process. Currently, everything is done on paper. In the spring, the state is launching a digital process which should make this a much easier process. General Counsel Bain

explained that this was another factor that the agency was waiting on, not wanting to be caught in the middle of the transition from paper to digital processing. Commissioner Haag asked if a regulation could be changed through the temporary regulation process. General Counsel Bain confirmed that it could, but it would still need to go through the state's approval process.






AGENDA ITEM: Peninsula Pacific Entertainment Development Material Debt Transaction Approval Request




Voluntary Exclusion Program January 2010 – February 2026
