MINUTES – JUNE 12, 2026

CALL TO ORDER (A.)

Chairman David Moses called the June 12, 2026, meeting to order at 10:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites and the agency's social media pages. Commissioners Brandon Jones, Larry Turnquist, and Natalie Haag were also present. Commissioner Mike Fleming is absent. Others present included Executive Director Don Brownlee, General Counsel James Bain, Director of IT&C-s Dennis Bachman, Director of Security, Licensing, and Backgrounds Roger Bailey, Director of Casino Operations Rick Wilson, Government Relations Manager Randy Evans, Director of Administration, Audit, and Finance Brandi White, and other staff. Chairman Moses acknowledged that Executive Director Don Brownlee is going to retire on June 20th and encouraged presenters to share their remarks when they are reporting. Chairman Moses recalled that Executive Director Brownlee has been with KRGC since 2015, that he was previously employed by the Kansas Highway Patrol and Kansas State Gaming before coming to KRGC. Chairman Moses said he wants to recognize and acknowledge the commitment Executive Director Brownlee has made to the State of Kansas. Chairman Moses noted that, with assistance of Commissioner Turnquist and Government Relations Manager Randy Evans, the commission received a letter from the Governor's Office acknowledging Executive Director Brownlee's service. Chairman Moses said that people say nice things about their bosses because they feel like they have to but does not recall having heard anything negative about Executive Director Brownlee whether they have worked with him or just know him. Chairman Moses said he believes he speaks for all the commissioners when he says that the commission could not be as successful as it has been without his leadership and friendship.

Brent Pritchett, General Manager, reported:

- General Manager Pritchett noted that he has not known Executive Director Brownlee for long but for time he has known him, the Executive Director has been very communicative and hospitable. General Manager Pritchett congratulated Executive Director Brownlee on his retirement.
- For the month of May 2026, Simulcast (Parimutuel) wagering as defined by the Kansas Racing and Gaming Commission produced a total takeout of \$82,655.43 with a total handle for simulcast at \$403,410.90.
- Historical Horse Racing Machines recorded a total handle of \$28,152,589.37.

- Chairman Moses noted that he lives in Wichita and has seen the local media regarding Gilley's newest entertainment contract and asked General Manager Pritchett to speak on that. General Manager Pritchett responded that Gilley's has contracted with Custom Entertainment, who sponsors the Country Stampede concerts, to hold the Country Stampede at Gilley's in June of 2027. Chairman Moses noted that this concert brings in a lot of people. General Manager Pritchett said that the acreage at the back of Gilley's can hold upwards of 30,000 people and that over a three-day event there could be 200,000 people coming through. Chairman Moses asked how long the agreement is for. General Manager Pritchett said that it is for two-years with the option to extend up to fifteen.

Jeff Longwell, Chair of Gilley's Cares, reported:

- Congratulated Executive Director Brownlee on his retirement and shared his appreciation with the assistance the Executive Director has provided the charity board.
- The board has written its first check to charity, there is about \$50,000 in their account, and they wrote their first check for \$10,000 to festivals. There are some other things that the board would like to do coming up with first responders and firefighters.
- Chairman Moses asked Mr. Longwell to inform him if anything comes up that requires a vote regarding the Wichita Metro Crime Commission in advance so that he can abstain.

Garrett Rogers, Paralegal, reported on both the Voluntary Exclusion Program and Sports Wagering Exclusion Program statistics for the month of May 2026.

Director of Administration, Audit, and Finance Brandi White reported:

- In May KRGC expenditures and obligations, the agency made a transfer of HHR revenue funds. The transfer in May was approximately \$612,649.82; \$171,996.99 was transferred to the Horse Breeding Development fund, the Horse Fair Benefit fund received \$417,357.63, and the transfer to the State Gaming Revenue fund was \$18,095.20. The fiscal year total column does still show the correct total balance of those funds currently. KRGC has not paid out any funds in the last month. KRGC did receive a request Wednesday afternoon and is still being evaluated.
 - Chairman Moses asked if that regards what the commission passed last month. Director White confirmed that it was.

Employees

During the 1st half of 2026, Kansas Star Casino processed 143 new team members through new hire orientation. All received the following training courses as part of orientation:

- Responsible Gaming with special emphasis on underage awareness and an overview of the Voluntary Exclusion Program
- Alcohol Awareness

In addition, team members are subject to a more intensive alcohol awareness training program called ServSafe. Team members that are trained include:

- All Front of House Food and Beverage managers and team members that participate in the serving of alcoholic beverages.
- All Security Staff
- All Valet Staff
- Slot Floorperson and above
- Table Games Dealers and above
- Surveillance Staff
- All Directors
- Sportsbook
- Cashiers Cage

ServSafe is a three-hour course with a test at the end which team members must pass with at least a 75% score. In the 1st half of 2026, 152 team members took and passed the ServSafe training, and 0 team members failed and were required to re-take the training until they received a passing score.

All training is done online with website 360training.com.

As of June 30, 2026, Kansas Star Casino had 589 active team members.



Ongoing Training

In addition to the training given in new hire orientation, all Kansas Star Casino team members undergo annual refresher training in Responsible Gaming. To make training more accessible we have the Responsible Gaming training module online in our suite of Skillsoft courses.

The total amount spent on responsible gaming materials was \$764.50, which was spent on ServSafe training, online services.

Daily Application

While all departments and team members are actively involved in preventing underage, intoxicated and self-excluded patrons from entering the casino floor and from gambling if they do gain access, the Security Officers stationed at the gated entrances are the primary method of prevention. Security follows the property's policy of checking IDs for people who appear 30 or younger; the statistics for these ID checks during the 1st half of 2026 are:

- Underage individuals denied gaming floor access: 147
- People denied access for not having ID: 214
- People denied for invalid ID: 215
- Intoxicated individuals denied gaming floor access: 101
- VEPs denied access to the gaming floor: 6

Further, there were 296 intoxicated individuals ejected from the casino, 6 VEPs were removed and turned over to the KRGC and the Mulvane Police Department, and 1 underage person were caught and ejected from the casino. Also, 155 persons were removed and 36 excluded from the casino for a variety of reasons.

During the 1st half of 2026, there were 597,657 guests who entered the casino floor. Security team members checked 81,772 IDs. In addition, 39 ID checks took place on the gaming floor in situations involving suspected minors.

1. Employees

At the end of the reporting period, Hollywood Casino had a total of 492 employees. During the reporting period, 74 employees were hired.

2. Responsible Gaming Training:

All employees hired during the reporting period received initial training on responsible gaming during property orientation. This consisted of approximately 30 minutes dedicated to responsible gaming. All employees successfully completed this training.

Of those new hires, 40 were hired into positions which require additional training to understand the proper procedures for responsible alcohol service. All of those employees successfully completed the TiPS training.

In addition, there were 23 existing employees who successfully completed refresher TiPS training.

3. Statistics:

To assist in tracking the success of the Responsible Gaming Plan, Hollywood Casino maintains statistics related to responsible gaming. Some of the numbers from the reporting period include:

- Hollywood Casino refused entry to 45 minors who attempted to gain access to the property.
- There were 2 minors who successfully gained access to the casino during the period.
- In addition, Hollywood Casino either refused entry to or removed 193 individuals from the property who appeared to be under the influence of alcohol.
- In addition to training officers to be observant at the casino entrances, Hollywood Casino has procedures in place to identify VEPs when they attempt to cash a check, perform a cash advance, attempt to claim a taxable jackpot, or attempt to create a Penn Play (player club) account. During the reporting period, Hollywood Casino discovered 10 VEPs on property. The local KRGC Agent on Duty was contacted immediately in each of these instances and took custody of the VEP for processing.

The Committee encourages the Commission to consider, in an effort to combat underage gambling and fraud, looking at consumer protection issues as those issues arise in the industry, and requiring each sports wagering platform to utilize know-your-customer websites that require photo verification, such as passive verification or active liveness verification, when a user creates a new sports wagering account or when a user places a wager.

BetMGM thanks the Kansas Racing and Gaming Commission for offering the opportunity to review and provide comments on the proposed Kansas Sports Wagering regulations. Leveraging its extensive expertise as a sports betting operator and its collaborative efforts with regulators in thirty jurisdictions during the formulation of their regulations, BetMGM aims to provide constructive input to enhance the effectiveness of Kansas operations and align the proposed procedures with the regulations of other states for consistency. The Kansas proposed amendments are listed below with BetMGM's proposed additions and removals to the proposed regulation in redline.

BetMGM respectfully submits the following comments for consideration.

112-201-10. Wager Cancellations.

Proposed Regulation Update:

Lottery gaming facility managers or the interactive sports wagering platform providers shall establish internal controls and house rules pertaining to wagering transactions that can be voided or cancelled.

- (a) A lottery gaming facility manager or the contracted interactive sports wagering platform provider shall ~~request approval from~~ promptly notify the executive director ~~after to~~ voiding or canceling an accepted wagering transaction due to an obvious error. An obvious error must be defined in the lottery gaming facility manager's or the contracted sports wagering platform's internal controls.
- (b) Except as otherwise provided in approved internal controls and house rules, a lottery gaming facility manager or the contracted interactive sports wagering platform provider shall not unilaterally void or cancel any wager without the prior approval of the executive director. (Authorized by and implementing K.S.A. 2023 Supp. 74-8772; effective T- .)

Reason for Revision:

BetMGM respectfully requests that this regulation be revised to permit operators to void wagers due to an obvious error without prior Commission approval, provided that the operator subsequently notifies the Commission in a timely manner.

BetMGM maintains that allowing operators discretion to void wagers in cases of obvious error, consistent with the current standard, offers the most efficient and least disruptive experience for customers. Requiring prior approval would require placing impacted wagers



on hold until approval is received, preventing customers from accessing the funds used to place those wagers.

By incorporating a notification requirement, the Commission would retain visibility into operators' voiding decisions while still allowing operators to act quickly to void wagers and promptly return funds to customers.

112-201-11. Reporting of suspicious activity.

Proposed Regulation Update:

(a) A lottery gaming facility manager or the interactive sports wagering platform shall utilize an independent supplier to identify non-normal irregularities in volume or odds swings that could signal suspicious activity and further investigation.

...

(b) Internal controls shall include direct reporting from the lottery gaming facility and the contracted interactive sports wagering platform to the commission within 14 days of becoming aware of the following activities:

...

(7) Any potential or actual breach of a sports governing body's internal rules and codes of conduct pertaining to sports wagering **activity on events overseen by that governing body** that is known to the lottery gaming facility of the contracted interactive sports wagering platform;

Reason for Revision:

BetMGM respectfully requests for this regulation to be limited to wagers placed on events overseen by the applicable governing body. This limitation is common in US state regulations and provides a commercially reasonable standard to achieve the regulation's intent.

Currently, BetMGM works closely with several governing bodies to ensure that people who are identified as prohibited participants are unable to wager on events overseen by that governing body. It is in the best interest of both BetMGM and sports governing bodies to prevent such wagering activity and preserve the integrity of the sporting event.

However, BetMGM is concerned with the breadth of this regulation. As drafted, this regulation imposes an onerous burden on operators by requiring them to enforce league rules and policies without regard to whether those rules relate to integrity concerns, are technically feasible to implement, or require unreasonable compliance costs and resources.

Additionally, the regulation grants governing bodies excessive authority by effectively allowing them to unilaterally establish wagering related policies that operators must enforce, without meaningful limitation or oversight.

For example, the NFL's current internal policy prohibits any affiliated person from wagering on any sporting event, even those that are not overseen by the NFL, while at an NFL facility. This policy is broader than any state regulation on this topic and does not consider whether the wagering activity actually affects the integrity of the event wagered on. Nevertheless, as drafted, 112-201-11(b)(7) would require operators to enforce the entirety of the NFL's current



policy and any other policy that the NFL (or any other governing body) implements in the future. This ultimately impacts operators' systems, customer interaction, and normal course of business without addressing any legitimate integrity concern.

112-203-2. Change management requirements.

Proposed Regulation Update:

(A) Substantial change includes changes to the security, integrity, recovery and availability of the sports betting system. Change request requires notification and approval of the change by the executive director prior to deployment.

(B) ~~Low impact~~ ~~Non~~-substantial changes (such as hardware changes, database maintenance, new features that do not impact regulatory functions) requires notification to the executive director and if no objection to the change is raised within three business days of receiving the notification, the change shall be deemed approved.

(C) Non-substantial changes that are purely cosmetic or may solely impact the version numbers or signature hashes of regulated components of the platform but do not impact any regulatory functions can be deployed without notification to the executive director or a wait period. Such changes would be recorded within the Change Management Log (CML), which is available for audit whether quarterly or upon request.

Reason for Revision:

BetMGM respectfully would like to note that GLI CMP allows for certain "non-substantial changes" to be logged within our Change Management Log, which is available for audit, whether quarterly or upon request. This conflicts with the proposed KS change management requirement 112-203-2 (3)(B) which states that all non-substantial changes be notified to the Executive Director. BetMGM proposes that the regulation include language explicitly permitting certain non-substantial changes, consistent with GLI CMP standards, to be recorded in the Change Management Log without requiring prior notification to the Executive Director, provided such changes remain available for audit or review upon request.

112-204-4. Pools and promotional activities.

Regulation Update:

(a) Pools may be conducted by the lottery gaming facility manager or the contracted interactive sports wagering platform provider providing the pool mechanic has prior approval by the executive director. The pool mechanic is deemed approved if no objection is raised by the executive director within three business days of submission.:

- (1) Pool mechanics shall be made available to participants for review prior to registering. Pool mechanics shall include, at a minimum: all conditions registered patrons must meet to qualify to enter or advance through the pool, available prizes or awards, fees, and distribution of prizes or awards based on specific outcomes.
- (2) Changes to pool mechanics shall not be made after participants have registered, unless approved by the executive director.
- (3) Results for pools with an entry fee shall be made available for the registered patrons to



review at the same location at which or in the same manner in which patrons registered. Results shall include, at a minimum: name of the event, date of the event, total number of entries, amount of entry fees, total prize pool, and amount paid for each winning category.

- (4) Fees collected less any prizes paid will be considered sports wagering revenue.
- (5) All emails or digital advertisements promoting pools shall include a link or other easily obtainable source that includes pool mechanics or terms and conditions.
- (6) Pools should comply with all federal, state, and local laws including 18 U.S.C. §1084.
- (7) Pool mechanics shall be submitted at least 14 days prior to the pool being active for patron registration.
- (8) The lottery gaming facility manager or the contracted interactive sports wagering platform provider shall maintain a digital log of all pools. All digital logs shall be made available to the commission for two years.

- (b) A lottery gaming facility or the contracted interactive sports wagering platform are prohibited from using the term “risk-free” in advertising and promotional activity. (Authorized by and implementing K.S.A. 2022 Supp. 74-8772; effective T- .)

Reason for Clarification:

BetMGM respectfully requests a definition for pools. If pools are a direct replacement of sports promotional contests and tournaments, we do not seek additional clarification however if the definition differs in any way, BetMGM would appreciate if the Commission can provide that definition.

We again want to express our appreciation for your thoughtful consideration of BetMGM’s feedback on the Kansas Racing and Gaming Commission’s proposed regulations. Upon finalization of the revised regulations, BetMGM would appreciate the opportunity to discuss the anticipated timeline for implementation. RE: INDUSTRY FEEDBACK TO PROPOSED REGULATIONS

Dear Mr. Bain:

In response to the Kansas Racing and Gaming Commission's (the "Commission") proposed regulations, 60-day comment period, and public hearing held July 17, 2026, DraftKings Inc. ("DraftKings") submits the following comments for consideration. As a leading sports wagering operator in the United States, DraftKings has first-hand experience with sports wagering regulatory frameworks, and submits these comments based on its operational knowledge in multiple regulated markets.

112-201-4. Issuance and sports wagering ticket control requirements.

Reason for Change:

DraftKings respectfully requests rephrasing this proposed regulation to avoid inadvertent confusion. The word "nonredeemable" as used in this context may be misleading because if it is voided/cancelled, the patron is nevertheless entitled to their initial wager amount.

Proposed Final Regulation Language:

- (a) Immediately upon accepting a wager, the interactive sports wagering platform shall create a sports wagering ticket on which the terms of the wager are written.
- (b) Printed sports wagering tickets must bear the name and address of the sports book.
- (c) An interactive sports wagering platform shall be capable of processing lost or destroyed sports wagering tickets.
- (d) When a sports wager is voided or canceled, the lottery gaming facility manager or the contracted interactive sports wagering platform provider shall clearly indicate that the sports wager is voided or canceled and ensuring it is nonredeemable for the patron's original wager amount. The voided or cancelled wager shall be logged into the interactive sports wagering platform indicating the void or cancellation and the identity of the cashier or automated process. (Authorized by and implementing K.S.A. 2023 Supp. 74-8772; effective P- _____.)



112-201-10. Wager cancellations.

Reason for Change:

DraftKings respectfully requests that the Commission permit operators to void wagers involving an obvious error without requiring case-by-case regulatory approval. The below approach more effectively addresses the underlying policy concern while preserving appropriate regulatory oversight.

DraftKings' proposed Kansas Internal Controls identify the specific circumstances under which a wager may be voided, including in cases of error, and DraftKings' House Rules further define "Error" and the circumstances that constitute an obvious error warranting a voided wager. This framework is consistent with K.A.R. 112-201-2(kk), which defines a "voided wager" as a sports wager voided by an employee of the lottery gaming facility manager or interactive sports wagering platform operator in accordance with the operator's approved internal controls or house rules.

Requiring Commission approval for each individual voided wager may create an unnecessary administrative burden for both the Commission and operators. It could also delay wager settlement, negatively affecting the patron experience. By contrast, the below framework preserves Commission oversight by limiting operators' authority to void wagers to the specific circumstances set forth in Commission-approved Internal Controls and House Rules, including documented obvious-error provisions. In addition, operators report all voided wagers to the Commission, providing ongoing regulatory visibility into the exercise of this authority.

Accordingly, this approach maintains meaningful Commission oversight through its approval of the governing Internal Controls and House Rules, as well as through post-void reporting, while avoiding the operational inefficiencies and patron impacts associated with requiring individual approval for every voided wager. Moreover, operators have a strong business incentive to exercise this authority sparingly and only in cases of genuine obvious error, as unnecessary voids undermine patron confidence and negatively affect the customer experience. In support of this approach, please see Arizona (R19-4-130(E-F))¹ and Colorado (1 CCR 207-2-7.6(12))².

Proposed Final Regulation Language:

Lottery gaming facility managers or the interactive sports wagering platform providers shall establish internal controls and house rules pertaining to wagering transactions that can be voided or cancelled.

- (a) A lottery gaming facility manager or the contracted interactive sports wagering platform provider shall ~~request approval from the executive director to~~ void or cancel an accepted wagering transaction due to an obvious error **within its commercially reasonable discretion**. An obvious error must be defined in the lottery gaming facility manager's or the contracted interactive sports

¹ E. The responsible party may cancel an accepted wager for obvious error as defined in the responsible party's internal control system. F. Except for obvious error, the responsible party shall not unilaterally cancel any wager without prior written approval of the Department.

² Cancellation of wagers. A Sports Betting Operation may, in its discretion, cancel an accepted wager for obvious error or in the case of a change in circumstance that makes grading the wager an impossibility. Obvious error shall be defined in the Sports Betting Operator's house rules. Any cancellation of wagers shall be reported to the Division.



wagering platform's internal controls.

- (b) Except as otherwise provided in approved internal controls and house rules, a lottery gaming facility manager or the contracted interactive sports wagering platform provider shall not unilaterally void or cancel any wager without the prior approval of the executive director. (Authorized by and implementing K.S.A. 2023 Supp. 74~8772; effective PM _____.)

112-201-16. Assign regulatory staff.

Reason for Change:

DraftKings respectfully requests the language below be added to the proposed rule to more narrowly tailor the potential scope of books, records, and email production requests. Reach as proposed may inadvertently extend to extraterritorial, privileged, and/or proprietary information or otherwise. The additional language ensures a more tailored approach.

Proposed Final Regulation Language:

The executive director at any time may require a lottery gaming facility manager or their contracted interactive sports wagering platform provider to allow commission staff to be permanently present on the sport book's premises, and to require the costs and expenses incurred by the assigned commission staff to be borne by the lottery gaming facility manager or their contracted interactive sports wagering platform provider in a manner deemed reasonable by the executive director. Commission staff shall have full and complete access to all books, records, and emails **reasonably related to the commission's regulatory oversight of sports wagering conducted pursuant to the Kansas Sports Wagering Regulations.**" (Authorized by K.S.A. 2023 Supp. 74-8772 and implementing K.S.A. 2023 Supp. 74-8752 and 74-8772; effective P- _____.)

112-201-19. Sports wagering voucher requirements.

Reason for Change:

DraftKings respectfully requests striking item (B)(8) as proposed. Sports wagering vouchers that are reissued following investigation are not duplicates of the original voucher. The original voucher is invalidated/redeemed, and a new voucher with a unique identifier is issued. Therefore, a duplicate designation is unnecessary and could inadvertently create confusion.

Proposed Final Regulation Language:

- (a) Payment by sports wagering voucher as a method of credit redemption is only permissible when the contracted interactive sports wagering platform supports this functionality.
- (b) A sports wagering voucher shall contain the following information:



- 1) Voucher serial number;
 - 2) sports book name and site identification;
 - 3) ticket writer or sports wagering kiosk that issued the voucher;
 - 4) date and time the sports wagering voucher was issued;
 - 5) numeric value of the sports wagering voucher in dollars and cents;
 - 6) voucher number that appears on the leading edge of the sports wagering paper voucher;
 - 7) bar code or any machine-readable code representing the validation number;
 - ~~8) indication if the sports wagering voucher is a duplicate;~~
 - 9) responsible gambling information; and
 - 10) indication of an expiration date which is 180 days from the date of issue.
- (c) The interactive sports wagering platform provider is required to keep and maintain a record of sports wagering vouchers issued by ticket writers or sports wagering kiosks. The sports wagering voucher record on the interactive sports wagering platform shall contain the following sports wagering voucher information;
- 1) Voucher serial number;
 - 2) date and time the sports wagering voucher was issued;
 - 3) type of transaction or other method of differentiating sports wagering voucher types;
 - 4) numeric value of the sports wagering voucher in dollars and cents;
 - 5) status of sports wagering voucher;
 - 6) date and time the sports wagering voucher will expire;
 - 7) ticket writer or sports wagering kiosk which issued the sports wagering voucher; and
 - 8) date and time the sports wagering voucher was redeemed, voided, or expired.
- (d) Before redeeming a sports wagering voucher, the complete validation number of the unredeemed sports wagering voucher shall be available to the interactive sports wagering platform provider.
- (e) Sports wagering vouchers shall be redeemed at a kiosk, point-of-sale, or ticket writer booths.
- (f) Upon presentation of a sports wagering voucher for redemption at a kiosk, point-of-sale, or ticket writer window, the interactive sports wagering platform shall be used to verify the validity of the serial number and value of the voucher, and if valid, the platform shall immediately update the sports wagering voucher status and permit the redemption of the voucher for the value indicated thereon.
- (g) The interactive sports wagering platform shall have the ability to identify errors or anomalies and notify the cashier or ticket writer that one of the following occurrences exists:
- 1) Sports wagering voucher serial number cannot be found;
 - 2) sports wagering voucher has already been paid; or
 - 3) amount of sports wagering voucher for confirmation by a cashier or ticket writer during the redemption process. (Authorized by and implementing K.S.A. 2023 Supp. 74-8772; effective P- .)

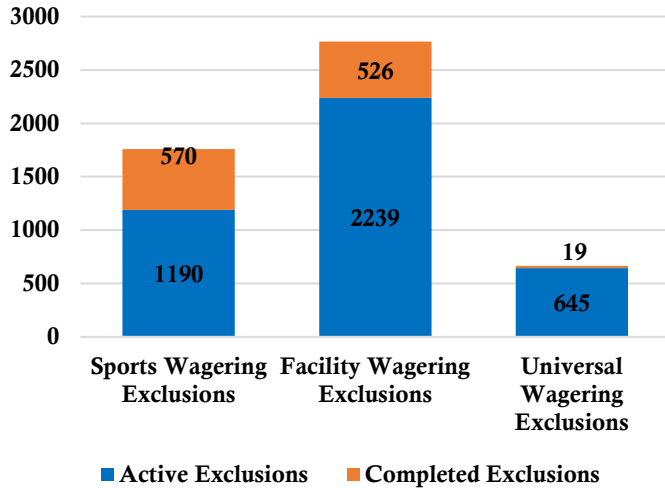

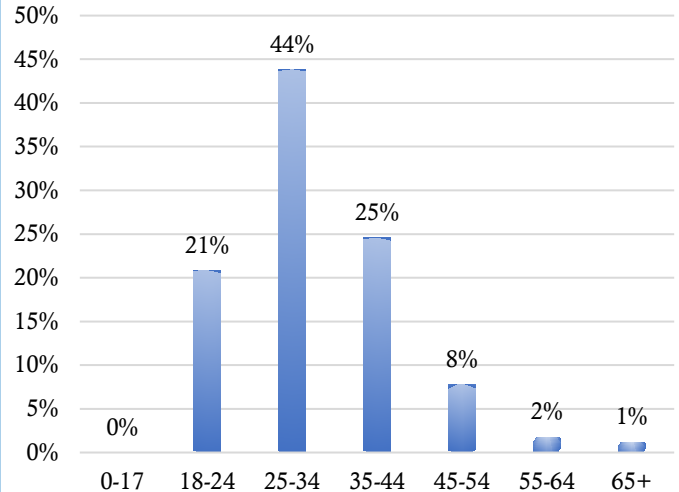

Total Number of Exclusions

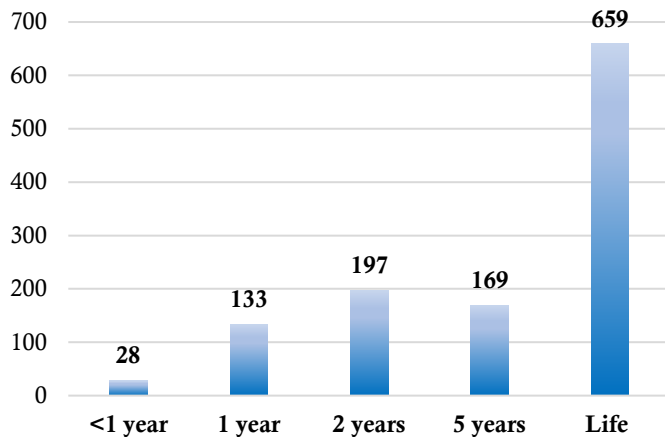


Age of SWEP

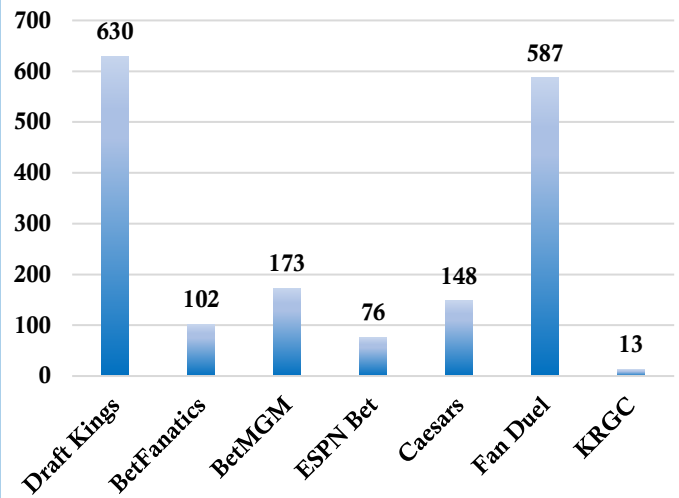


Active Sports Wagering Exclusion Durations

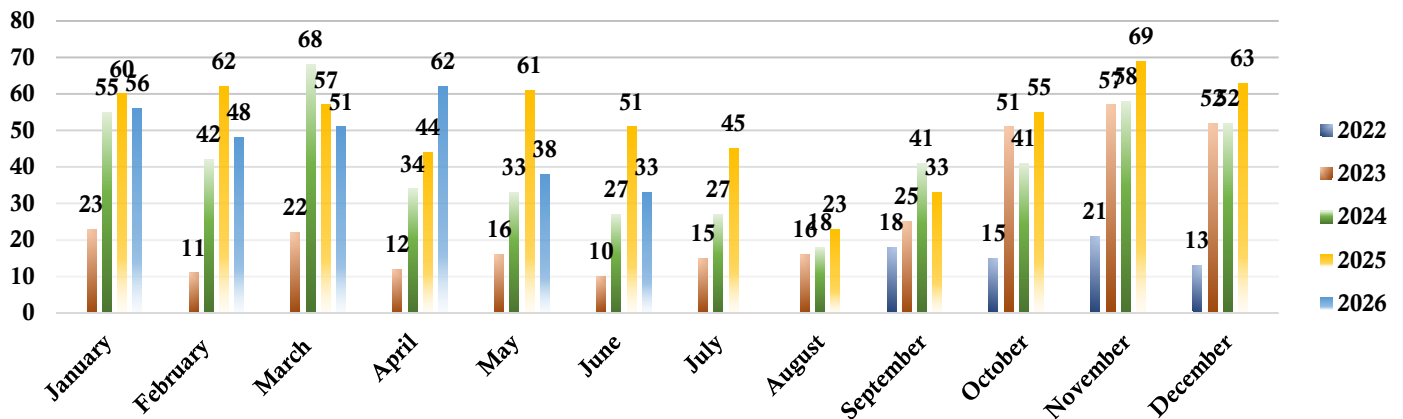

SWE Enrollment by Platform*



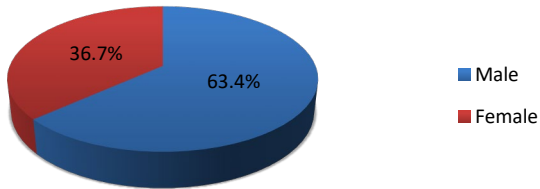
SPORTS WAGERING EXCLUSION ENROLLMENT BY MONTH



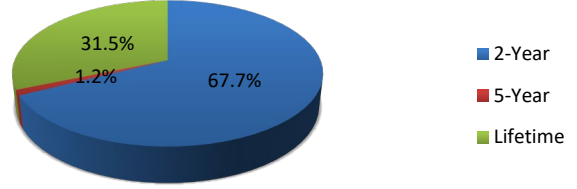

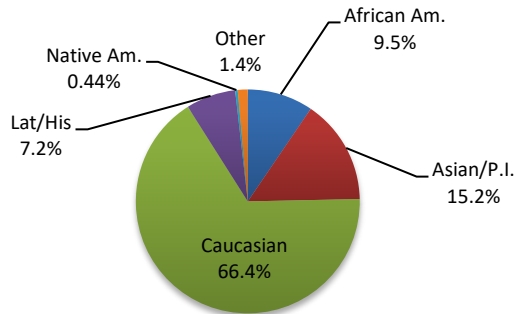
VEP Gender



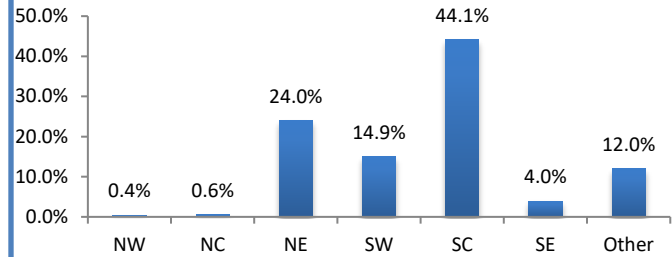

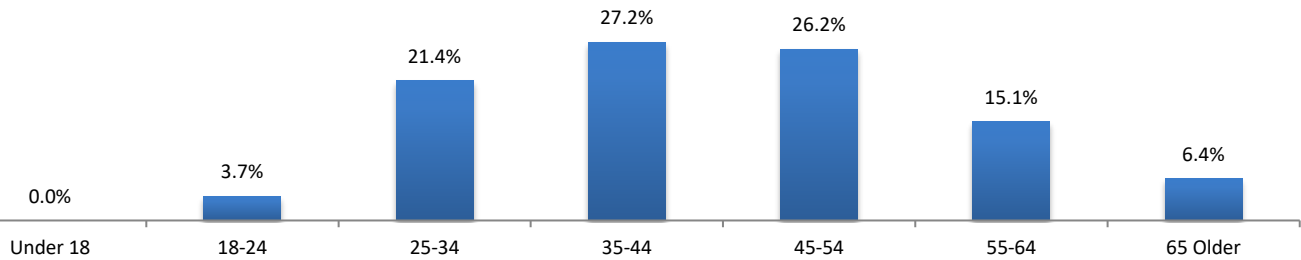

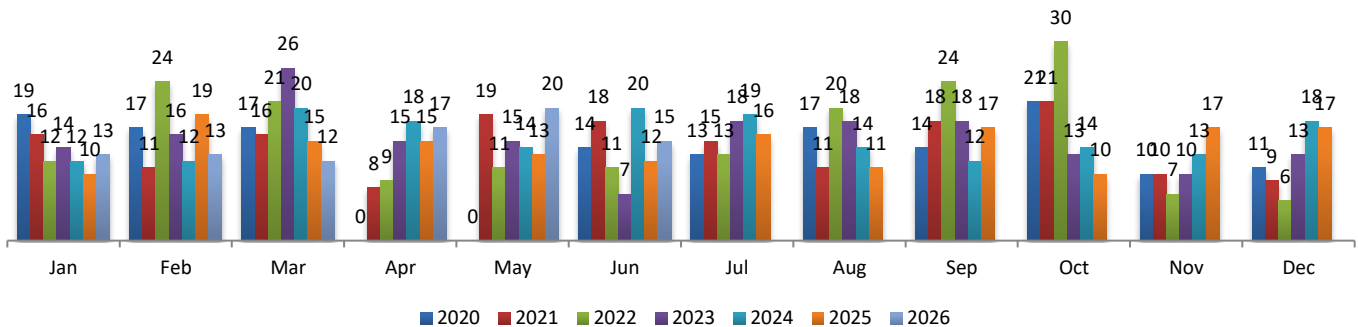
Lottery Region



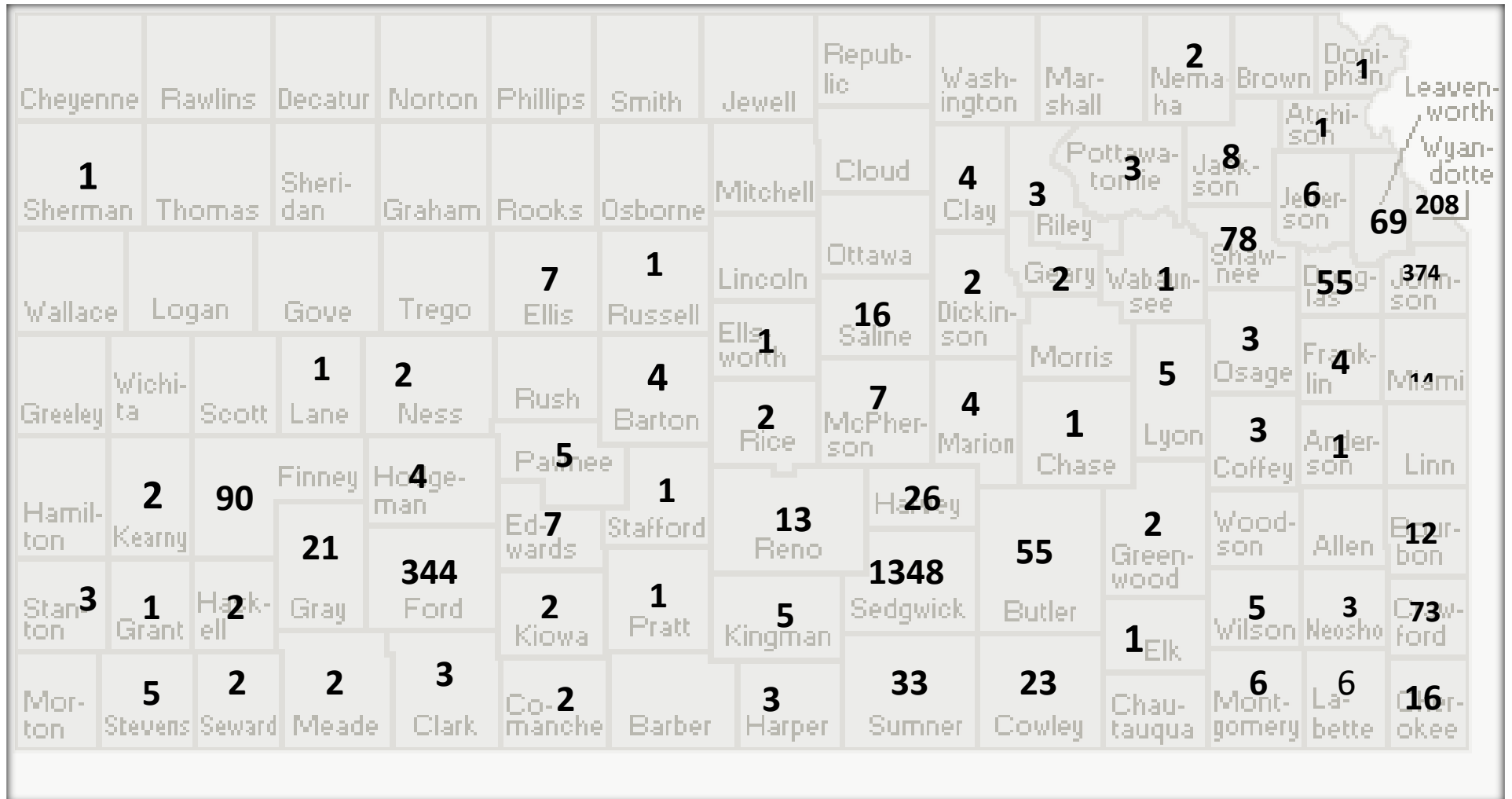
Age of VEP

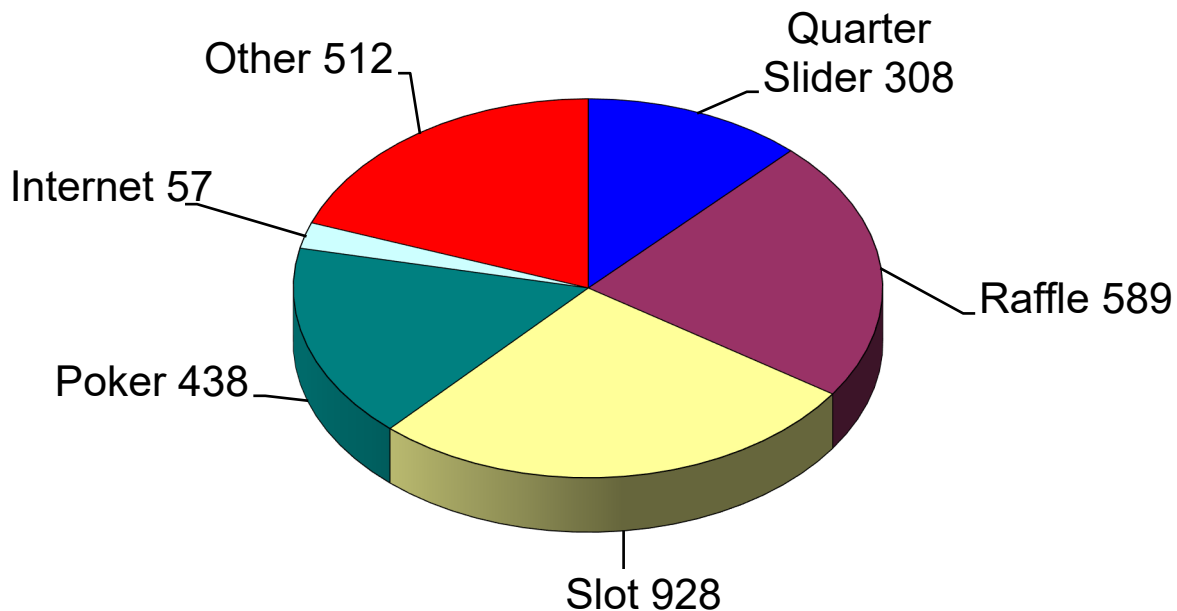

III. ILLEGAL GAMBLING

The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,832 total illegal gambling-related questions or complaints from the general public. During the second quarter (Q-2) of 2026, the Commission received eleven (11) calls and emails from the general public, down sixteen (16) from the previous quarter and down fourteen (14) from the second quarter of 2025.

Of the eleven (11) calls and emails received in Q-2, ten (10) involved slot machines and one (1) involved raffles.

Breakdown of illegal gambling inquiries and complaints to-date:

The above chart does not reflect calls and activity related to the following:

- Reports made to KRGC agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGC can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.
- Inquiries from the public that are answered through access to KRGC's Illegal Gambling Frequently Asked Questions (FAQs) web page.

KRGC updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGC began tracking the new page, there have been a total of 32,077 unique page views (after adjustments). A total of 675 unique page views were made during the second quarter of 2026, down 143 from the previous quarter (adjusted) and down 292 from the second quarter of 2025 (adjusted).
