John C. Frieden, Frieden & Forbes, LLP presented the Kansas Crossing Casino's material debt transaction approval request. B.C. Christianson, Lead Principal of Kansas Crossing Real Estate and Kansas Crossing Casino, thanked the commissioners and staff for their efforts and remained available for questions.

There were no public comments.

Garrett Rogers, Paralegal, reported on the Voluntary Exclusion Program statistics for the month of December 2021 and the Quarterly Illegal Gambling Report.

Todd Allen, Government Relations Manager, gave a gaming legislation report:

- Provided overview of SB 84 and HB 2199
- Commissioner Kultala asked that a physical report also be provided. Chairman Moses stated that he would like to work with KRGC's General Counsel to ensure compliance with applicable agency regulations and state statutes.
- Chairman Moses requested that the fiscal impact of proposed legislation be highlighted in future reports.

Executive Director Brownlee reported:

- Governor's proposed budget for fiscal year 2022 does not have any changes to KRGC budget request.
 - Governor Kelly has asked the legislature to approve a 5% pay increase for all state employees.
- Ohio allows sports betting online, in casinos, in racinos, and by stand-alone kiosks in bars and restaurants. Sports betting in Ohio is regulated by the Ohio Casino Control Commission.

- The Kentucky legislature passed legislation to approve historical horse racing. Consequently, there is a 60,000sq. ft. historical horse racing venue being constructed in Owensboro, Kentucky.
- Attorney General Schmidt has filed a lawsuit regarding the establishment of the CrossWinds Casino in Park City
- Confirmed next meeting is scheduled for February 11th at 9:30 a.m.




Voluntary Exclusion Program January 2010 – January 2022


VEP Gender




Exclusion Period




Ethnicity




Lottery Region



Age of VEP




VEP Enrollments by Year
