STAFF REPORTS
(I.1. and I.2.)

Judith Taylor, General Counsel, reported on the Voluntary Exclusion Program statistics for the month of May 2022.

- Chairman Moses requested more information regarding the appropriation of funds from the Problem Gambling and Addictions Grant Fund, particularly the ninety percent used for other addictions instead of gambling addiction. The chairman requested that a speaker from KDADS be present at the July meeting to explain how this fund is appropriated.

Todd Allen, Director of Sports Wagering, reported:

- Regarding the allocation of Problem Gambling and Addiction Fund monies, SB 84 requires that KDADS give a report to both House and Senate Federal and State Affairs committees each year.
- SB84 established an August 1st deadline for KRGC to develop a process for conducting background checks of interactive sports wagering platforms and notify the Facility Managers of that process. KRGC is well underway in that process.
- Draft regulations are being developed. The goal is to have draft regulations to the Facility Managers for comment by the end of the month.
- Commissioner Turnquist asked if the new background process will be similar to the existing process for background checks. Director Allen stated that the process does have similarities, but statute requires some aspects not present in the current process.
- Commissioner Kultala asked for clarification on whether the August 1st deadline was for submission of draft regulations or establishment of permanent regulations, and if the regulations were for the vendors. Director Allen clarified that the August 1st deadline only pertains to the background process. The permanent regulations are due January 1, 2023 and will encompass all aspects of sports wagering.
- Commissioner Turnquist asked if the establishment of the new background process would require temporary regulations. Executive Director Brownlee explained that SB 84 gives authority to the Executive Director to develop that

process, and commission approval is not required, though the commission would be informed.

- Chairman Moses asked if SB 84 created a specified Director of Sports Wagering position. Director Allen explained the position was established out of need and was not a statutory requirement.

Executive Director Brownlee reported:

- Executive Director Brownlee apologized to any sports wagering platform companies for any miscommunication about the meeting that occurred prior to today's meeting and clarified that the meeting was for facility managers only.
- IT staff have been upgrading security measures and increasing cybersecurity training for KRGC staff.
- The next meeting is scheduled for 10:00 a.m. on July 22nd at the Downtown Ramada.

Employees

During the first half of 2022, Kansas Star Casino processed 116 new team members through new hire orientation. All received the following training courses as part of orientation:

- Responsible Gaming with special emphasis on underage awareness and an overview of the Voluntary Exclusion Program
- Alcohol Awareness

In addition, team members are subject to a more intensive alcohol awareness training program called, ServSafe. Team members that are trained includes:

- All Front of House Food and Beverage team members that participate in the serving of alcoholic beverages.
- All Security Staff
- All Valet Staff
- Slot Floorperson and above
- Table Games Dealers and above
- Surveillance
- All Directors

ServSafe is a three-hour course with a test at the end which team members must pass with at least a 75% score. In the first half of 2022, 142 team members took the ServSafe training, and 9 team members failed, and 9 team members will be required to re-take until they pass the course.

Kristi Lubash, Beverage Manager is the Kansas Star Casino certified ServSafe trainer and administers all classes.

The Kansas Star Casino Responsible Gaming trainers are:

- Alecia Pray, Director of Human Resources
- Miranda Fields, Human Resources Manager
- Marlene Rivera, Human Resources Specialist

As of June 30, 2022, Kansas Star Casino had 635 active team members.

Ongoing Training

In addition to the training given in new hire orientation, all Kansas Star Casino team members undergo annual refresher training in Responsible Gaming. To make training more accessible we have the Responsible Gaming training module online in our suite of Skillsoft courses.

The total amount spent on responsible gaming materials was \$2,058.10, which was spent on ServSafe training manuals.

Daily Application

While all departments and team members are actively involved in preventing underage, intoxicated and self-excluded patrons from entering the casino floor and from gambling if they do gain access, the Security Officers stationed at the gated entrances are the primary method of prevention. Security follows the property's policy of checking IDs for people who appear 30 or younger; the statistics for these ID checks during the first half of 2022 are:

- Underage individuals denied gaming floor access: 119.
- People denied access for not having ID: 530.
- People denied for invalid ID: 336.
- Intoxicated individuals denied gaming floor access: 103.
- VEPs denied access to the gaming floor: 2.

Further, there were 173 intoxicated individuals ejected from the casino, 9 VEPs were removed and turned over to the KRGC and the Mulvane Police Department; 3 underage persons were caught and ejected from the casino. Also, 135 persons were removed from the casino for a variety of reasons.

During the first half of 2022, there were 602,389 guests who entered the casino floor. Security team members checked 79,412 IDs. In addition, 90 ID checks took place on the gaming floor in situations involving suspected minors.

Several other ongoing efforts are noteworthy as the Kansas Star Casino is an active member and participant in the Kansas Coalition on Problem Gambling, Problem Gambling Program Committee, and the South-Central Task Force on Problem Gambling.

Kansas Star Casino was a sponsor of the 19th Annual Virtual Midwest Conference on Problem Gambling and Substance Abuse which took place June 15-16, 2022. Kansas Star Casino provided a Premiere Scholarship at \$5000.00. With the sponsorship, Kansas Star Casino will have its logo placed on the website for the conference. In addition, Kansas Star Casino also provided 150 coupons for a "Free Appetizer" to our Tin Lizard restaurant, which was included in the attendee's registration packets.

1. Employees

At the end of the reporting period, Hollywood Casino has a total of 331 employees. During the reporting period, 90 employees were hired.

2. Responsible Gaming Training:

All employees hired during the reporting period received initial training on responsible gaming during property orientation. This consisted of approximately 30 minutes dedicated to responsible gaming. All employees successfully completed this training.

Of those new hires, 35 were hired into positions which require additional training to understand the proper procedures for responsible alcohol service. All of those employees successfully completed the TiPS training.

In addition, there were 33 existing employees who successfully completed refresher TiPS training.

3. Statistics:

To assist in tracking the success of the Responsible Gaming Plan, Hollywood Casino maintains statistics related to responsible gaming. Some of the numbers from the reporting period include:

- Hollywood Casino refused entry to 40 minors who attempted to gain access to the property.
- There was one minor who successfully gained access to the casino during the period.
- In addition, Hollywood Casino either refused entry to or removed from the property 181 individuals who appeared to be under the influence of alcohol.
- In addition to training officers to be observant at the casino entrances, Hollywood Casino has procedures in place to identify VEPs when they attempt to cash a check, perform a cash advance, attempt to claim a taxable jackpot, or attempt to create a mychoice (player club) account. During the reporting period, Hollywood Casino discovered 23 VEPs on property. The local KRGC Agent on Duty was contacted immediately in each of these instances and took custody of the VEP for processing.


Voluntary Exclusion Program

January 2010 – June 2022




VEP Gender




Exclusion Period




Ethnicity




Lottery Region

II. LICENSING

Objectives of the commission include conducting timely, but thorough, background investigations on all gaming employees, management contractors, manufacturers and distributors seeking licensure at lottery gaming facilities located in this state. Background investigations are conducted to protect the public interest by maintaining a legitimate and viable gaming industry assuring honesty, good character and integrity of racing and gaming facility operators, employees, and vendors. Following is the licensing report for the January through March 2022 quarter. The three previous quarters are included for comparison purposes.

III. ILLEGAL GAMBLING


The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,531 total illegal gambling-related questions or complaints from the general public. During the second quarter (Q-2) of 2022, the Commission received seventeen (17) calls and emails from the general public, down five (5) from the previous quarter and down twenty-six (26) from the second quarter of 2021.

Of the seventeen (17) calls and emails received in Q-2, four (4) involved slot machines; three (3) involved raffles; three (3) involved poker; two (2) involved quarter pushers; and five (5) involved other types of gambling. Of the five (5) other calls received, three (3) involved Fantasy Sports, one (1) involved online blackjack, and one (1) involved a non-reel electronic gambling device.

Breakdown of illegal gambling inquiries and complaints to-date:




The above chart does not reflect calls and activity related to the following:

- Reports made to KRGC agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGC can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.
- Inquiries from the public that are answered through access to KRGC's Illegal Gambling Frequently Asked Questions (FAQs) web page.

KRGC updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGC began tracking the new page, there have been a total of 21,032 unique page views (after adjustments). A total of 513 unique page views were made during the second quarter of 2022, down 4 from the previous quarter (adjusted) and up 18 from the second quarter of 2021 (adjusted).
