Chairman David Moses called the May 12, 2023, meeting to order at 10:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites. Commissioners Brandon Jones, Larry Turnquist, and Sheryl Spalding were also present. Others present included Executive Director Don Brownlee, General Counsel Judith Taylor, Director of Administration, Audit, and Finance Brandi White, Director of Sports Wagering and Licensing DJ Lopez, Director of IT&C-s Dennis Bachman, and other staff.

- April 2023 Sports Wagering
 - \$39.78 million was wagered on FanDuel online.
 - \$1.30 million was wagered in person at FanDuel retail. Of this #, 767k was bet over the counter and
 - \$533k was bet on the kiosks.
 - There was a total of 8,591 bets made in person at FanDuel retail.
 - The largest wager in retail was \$29,700 bet on Gervonta Davis to defeat Ryan Garcia in a boxing match on April 22. This wager was a winner, and the total payout was \$41,580.
 - The largest parlay in retail was a \$13,400 two team parlay with the Toronto Blue Jays ML and the
 - Boston Bruins ML on April 11. This was a winner, and the total payout was \$23,400.
 - Our biggest player at Sportsbook wagered a total of \$224,960.
 - The Retail Sportsbook had an increase in handle of almost 9% over March. (\$1.30 million in April vs.
 - \$1.17 in March)
 - The increase in handle in April over March was a nice surprise due to the popularity of College Basketball in Kansas and March Madness.
 - We had 1 PPV UFC Fight in the month on April 8. There was \$50,872 bet on this fight and 257 bets made.

STAFF REPORTS
(I.1. and I.2.)

Garrett Rogers, Paralegal, reported on the Voluntary Exclusion Program statistics for the month of April 2023.

Executive Director Brownlee reported:

- James Bain has joined the KRGC legal staff.

- The legislation regarding an increase in pay for some state employees was passed. The KRGC Human Resources Director is evaluating how that legislation will affect KRGC employees.
- Neither Missouri nor Oklahoma passed sports wagering this legislative session.
- Nebraska has announced the opening of the WarHorse Casino in Lincoln, Nebraska by the end of May. Another WarHorse Casino is close behind in Omaha, Nebraska and are several others planned.
- Governor Kelly's administration has agreed to a compact amendment with the Prairie Band tribe, allowing the tribe to provide sports wagering statewide. There is an ongoing federal court case to determine whether remote wagering is compliant with Indian Gaming Regulatory Act. The Prairie Band sports wagering will be regulated by the Tribal Gaming Commission. The compact still needs to be approved by the U.S. Department of the Interior.
 - Commissioner Spalding asked for elaboration on the compact changes. Executive Director Brownlee explained that the compact with the tribe was amended to allow the tribe to conduct sports wagering. It appears at this time, that those amendments would allow the tribe to offer on-site sports wagering and remote sports wagering. However, before the tribe offers sports wagering there are a couple other hurdles that need to be cleared, the federal court case and federal approval of the compact. Commissioner Spalding asked if the tribe would be able to establish sports wagering kiosks off-site. Executive Director Brownlee clarified that the remote sports wagering would be done online and that on-site they could choose to have sportsbook.
 - Commissioner Spalding clarified that this was only regarding tribal sports wagering and no other forms of gaming. Executive Director Brownlee affirmed that was correct.
 - Chairman Moses asked if the statutory guidelines that apply to non-tribal sports wagering were adopted, or are required to be followed, by the amended compact. Executive Director Brownlee said that his understanding is that there were attempts to make those amendments within the compact as to not give any advantage to tribal sports wagering over state lottery sports wagering. However, because KRGC is not involved with compact negotiations he cannot be sure how that resolved, or the exact language used.
 - Chairman Moses asked if the tribal casino located in Sedgwick County will be able to provide tribal sports wagering once the

Department of the Interior has approved the compact. Executive Director Brownlee explained that re-negotiated compact only applies to the Prairie Band tribe and that Park City is not a compacted state in Kansas. Chairman Moses asked what regulations are currently applied to Park City. Director Brownlee explained that the Indian Gaming Regulatory Act is the regulatory authority and that his understanding is the act bars sports wagering. Chairman Moses noted that the Indian Gaming Regulatory Act could be amended in the future.

- Investigations are underway in Iowa regarding sports wagering issues involving the Iowa University and Iowa State University. The issues center around athletes at those universities placing bets either illegal or at least in violation of NCAA rules. Investigations are being conducted by the Iowa Division of Criminal Investigations and the NCAA. Between the two universities there are alleged to be over 40 athletes from various sports involved in the investigation.
- There is an investigation going into whether the Alabama baseball program coach provided inside information to a bettor regarding the LSU game. When that information was discovered, several jurisdictions suspended wagering on that particular game, some jurisdictions have suspended wagering on all Alabama baseball. Kansas is among the jurisdictions that suspended wagering on all Alabama baseball. If the integrity of a game or a sporting event comes into questions, betting for that event can be suspended. That took place following the concerns of the Alabama vs. LSU game. However, the Iowa concerns were not believed to affect the integrity of any specific events. Alerts are built into the sports wagering system to provide notice of unusual, abnormal, and irregular betting activity so that the commission can review any questionable activities centered on sports wagering. To date the commission has not been made aware of any concerns involving Kansas athletes.
 - Commissioner Turnquist asked who in Kansas makes the decision to suspend wagering on an event. Executive Director Brownlee explained that the Kansas State Lottery makes that determination. KRGC and the Lottery work closely together, especially in these instances. Once KRGC was notified of the situation, they provided the information to the Lottery who acted.
- Historical Horse Racing regulations have been moving through the Kansas Department of Administration. Out of all the regulations submitted, only two are currently still being worked through the approval process.

- Chairman Moses asked if the two pending regulations are substantive enough that they need to be known by the public and applicants for the purposes of the meeting. Executive Director Brownlee assured that the contents of the pending regulations are not material to the meeting.
- Government Relations Manager Randy Evans will coordinate the logistics of the HHR selection process. The selection for historical horse racing organizational license has been scheduled for July 11-13. Those presentations will take place in Wichita, at the Drury Inn Broadview Conference Center.
- Government Relations Manager Randy Evans on May 11th sent notices to the area government entities informing them about the process and soliciting any comments from them. He is also in the process of notifying county media outlets. His press release will include instruction on how interested parties can submit information in writing to the commission or appear in-person. This information will also be posted on the KRGC agency website and social media.
 - Chairman Moses thanked Randy for keeping the commissioners apprised of the media releases and asked if anyone planning to provide public comment needs to provide notice. Executive Director Brownlee said that KRGC has asked the area government entities to provide notice if they are planning to present. Regarding members of the public, they do not need to provide any notice. Chairman Moses asked if there is a deadline for written comment. Executive Director Brownlee said there is not an established deadline, but one could be included in future releases.
- The next commission meeting is scheduled to be in Topeka, KS on June 16th, 2023, starting at 9:00am.



January 2010 – May 2023




VEP Gender




Exclusion Period








Age of VEP
