CALL TO ORDER

Chairman David Moses called the June 14, 2024, meeting to order at 10:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites and the agency's social media pages. Commissioners Brandon Jones, Larry Turnquist, and Mike Fleming were also present. Others present included Executive Director Don Brownlee, General Counsel Judith Taylor, Director of IT&C-s Dennis Bachman, Director of Security Roger Bailey, and other staff.

Ryan Deutsch, Assistant General Manager, reported:

- May 2024 revenue numbers compared to May 2023:

- Assistant General Manager Deutsch noted that harvest is about to begin in south western Kansas. January through May the area had just over two inches of rain, where the historical average is about six and a half inches, but over the last 10-days the area has had just over six inches of rainfall.
- General Manager Deutsch reported that the sportsbook did have pre-live wagering option for the Wichita Open Tournament.
 - Chairman Moses noted that Sam Stevens is playing because he was not able to attend the US Open. Assistant General Manager Deutsch explained that he imagines that he would be a strong favorite and that if there were a lot of handle, he would take the majority as the local kid.
- Chairman Moses noted that the advertisements for the Gabby Barrett also show she will be appearing at the Kansas Star. Assistant General Manager Deutsch confirmed that the artist was appearing at the Kansas Star first because it was an easier route.

Justin Willenbrink, Director of Table Games, reported:

- May 2024 revenue numbers compared to May 2023:
 - Total gross gaming revenue was increased 9.2%
 - Total slot revenue up 5.4%
 - Table games revenue up 28.8%
- May 2024 Sports Wagering revenue
 - Retail Sportsbook Revenue \$143,600.00.
 - Up compared to May 2023's revenue of \$130,100.00.
 - Digital Sportsbook Revenue: \$4,970,000.00
 - Up from May 2023's revenue of \$3,480,000.00.
- May 2024 Sports Wagering
 - \$51.3 million was wagered on FanDuel online.
 - There were 7,681 bets made in person at FanDuel retail.
 - The total handle in retail was \$748k for May.
 - The largest wager in retail was a \$10,000 straight wager on the St. Louis Cardinals in Major League Baseball. The wager was a winner and paid out \$15,434.
 - Our largest customer in retail wagered \$101,287 for May. This customer lost \$12,316 in the month.
 - NBA and MLB were the most bet on sports in May.

- Chairman Moses asked how the ticket sales for Gabby Barrett were. Director Willenbrink responded that he did not have that information but could provide it the commissioners after the meeting.
- Chairman Moses noted that the facility is running noticeable advertisements in local media. Director Willenbrink explained that the Marketing team is always trying to mix things up and keep things fresh.
- Chairman Moses asked if this was the month of the GM cruise. Director Willenbrink confirmed it was.

Lydia Garvey, General Manager, reported:

- May 2024 admissions were up 4.3% compared to May 2023
- May 2024 revenue numbers compared to May 2023:
 - Total gross gaming revenue increased 16%
 - General Manager Garvey noted that this was the best May in the history of the property.
 - Slot revenue increased 14.9%
 - Table games revenue increased 26.9%
- May 2024 Sports Wagering revenue numbers
 - Retail Sportsbook Taxable Revenue: \$388,132.00
 - Flat compared to May 2023
 - Handle was up 93% compared to last year, but hold was down substantially.
 - The May NASCAR event had 1,429 wagers and a total handle of about \$110,000. The facility lost \$24,000 on the May races. Though it was not good for the sportsbook, it was

good for the property; there were increased promotional activities and additional digital advertising.

 - NBA was 33% of handle
 - MLB was 40% of handle
 - NHL was 7% of handle
- Digital Sportsbook Taxable Revenue: \$993,728.00
 - Up 79.2% compared to May 2023
 - Handle was up 63%

 - MLB was 36% of handle
 - NBA was 32% of handle
 - NHL was 5.3% of handle

- General Manager Garvey introduced new additional to the facility's leadership team; Pat Murphy joined as CFO and Vice President of Finance and Ryan Rose joined Vice President of Gaming Operations. Chairman Moses welcomed the new additions.
- Commissioner Turnquist asked if the facility was actively involved in the lobbying for the Kansas City Chiefs to come to Kansas. General Manager Garvey explained that they are not actively involved but are anxiously waiting to see what will happen in the legislature with the Star Bonds.
- Commissioner Fleming asked what it would mean for the facility if Missouri were to pass sports wagering. General Manager Garvey responded saying that it will definitely have an impact of them, and the facility has been aware of this potential, so the property has focused on building loyalty with the existing patrons. The facility is also using its digital sportsbook to get online customers to come and visit the facility.
 - Commissioner Fleming asked if there was any organized opposition to the effort. General Manager Garvey responded that there is not a substantial opposition, but there have been concerns regarding responsible gaming.
- Chairman Moses noted that KU Basketball will be playing some of their games near the facility. General Manager Garvey said that the facility reached out to KU to see if there was interest in partnering, but the cost to partner is too high. Chairman Moses asked if the facility would do any independent marketing. General Manager Garvey said that the facility will try and take advantage of the crowd.

Scott Beeler, Golden Circle Representative, reported:

- The charity board has selected the fifth and final board member. Maria Ruiz-Heimerman, a sergeant with the Wichita Police Department, was selected and has submitted her background to KRGC staff.
 - Chairman Moses asked if Sergeant Ruiz-Heimerman is on the patrol side or another division of the department. Mr. Beeler responded that he does not know. Chairman Moses noted that the commission would learn more once her background was reviewed.
- Tim Merrell has been selected as the General Manager, and Courtney Barnaby will be the Executive Vice President. Shane Bollinder has been selected as the Assistant General Manager and Chris Brandt will be the Director of Operations. All four individuals are in the process of finalizing their submittal packets for backgrounding and licensing. Those are due by July 1 and the Golden Circle executive team is on target to submit by the deadline.
- Construction continues as scheduled and at budget. A link was created and submitted to KRGC that will allow staff to review the full site plans at any time.

Responsible Gaming Report for January 1, 2024 – June 30, 2024

Employees

During the first half of 2024, Kansas Star Casino processed 123 new team members through new hire orientation. All received the following training courses as part of orientation:

- Responsible Gaming with special emphasis on underage awareness and an overview of the Voluntary Exclusion Program
- Alcohol Awareness

In addition, team members are subject to a more intensive alcohol awareness training program called, ServSafe. Team members that are trained includes:

- All Front of House Food and Beverage managers and team members that participate in the serving of alcoholic beverages.
- All Security Staff
- All Valet Staff
- Slot Floorperson and above
- Table Games Dealers and above
- Surveillance Staff
- All Directors

ServSafe is a three-hour course with a test at the end which team members must pass with at least a 75% score. In the first half of 2024, 160 team members took and passed the ServSafe training, and 0 team members failed and were required to re-take the training until they received a passing score.

All training is done online with website 360training.com.

The Kansas Star Casino Responsible Gaming trainers are:

- Alecia Pray, Director of Human Resources
- Miranda Fields, Human Resources Manager
- Marlene Rivera, Senior Human Resources Specialist

As of June 30, 2024, Kansas Star Casino had 605 active team members.



Ongoing Training

In addition to the training given in new hire orientation, all Kansas Star Casino team members undergo annual refresher training in Responsible Gaming. To make training more accessible we have the Responsible Gaming training module online in our suite of Skillsoft courses.

The total amount spent on responsible gaming materials was \$1112.00, which was spent on ServSafe training, online services.

Daily Application

While all departments and team members are actively involved in preventing underage, intoxicated and self-excluded patrons from entering the casino floor and from gambling if they do gain access, the Security Officers stationed at the gated entrances are the primary method of prevention. Security follows the property's policy of checking IDs for people who appear 30 or younger; the statistics for these ID checks during the second half of 2024 are:

- Underage individuals denied gaming floor access: 125
- People denied access for not having ID: 406
- People denied for invalid ID: 315
- Intoxicated individuals denied gaming floor access: 93
- VEPs denied access to the gaming floor: 11

Further, there were 254 intoxicated individuals ejected from the casino, 9 VEPs were removed and turned over to the KRGC and the Mulvane Police Department, and 1 underage person were caught and ejected from the casino. Also, 105 persons were removed and 16 excluded from the casino for a variety of reasons.

During the first half of 2024, there were 633,656 guests who entered the casino floor. Security team members checked 82,740 IDs. In addition, 70 ID checks took place on the gaming floor in situations involving suspected minors.

Several other ongoing efforts are noteworthy as the Kansas Star Casino is an active member and participant in the Kansas Coalition on Problem Gambling, Problem Gambling Program Committee, and the South-Central Task Force on Problem Gambling.

Hollywood Casino at Kansas Speedway
Responsible Gambling Plan Semi-Annual Report
January 1, 2024 thru June 30, 2024

1. Employees

At the end of the reporting period, Hollywood Casino had a total of 457 employees. During the reporting period, 154 employees were hired.

2. Responsible Gaming Training:

All employees hired during the reporting period received initial training on responsible gaming during property orientation. This consisted of approximately 30 minutes dedicated to responsible gaming. All employees successfully completed this training.

Of those new hires, 57 were hired into positions which require additional training to understand the proper procedures for responsible alcohol service. All of those employees successfully completed the TiPS training.

In addition, there were 13 existing employees who successfully completed refresher TiPS training.

3. Statistics:

To assist in tracking the success of the Responsible Gaming Plan, Hollywood Casino maintains statistics related to responsible gaming. Some of the numbers from the reporting period include:

- Hollywood Casino refused entry to 58 minors who attempted to gain access to the property.
- There were 3 minors who successfully gained access to the casino during the period.
- In addition, Hollywood Casino either refused entry to or removed from the property 128 individuals who appeared to be under the influence of alcohol.
- In addition to training officers to be observant at the casino entrances, Hollywood Casino has procedures in place to identify VEPs when they attempt to cash a check, perform a cash advance, attempt to claim a taxable jackpot, or attempt to create a Penn Play (player club) account. During the reporting period, Hollywood Casino discovered 5 VEPs on property. The local KRG Agent on Duty was contacted immediately in each of these instances and took custody of the VEP for processing.





Total Number of Exclusions






Active Sports Wagering Exclusion Durations



SPORTS WAGERING EXCLUSION ENROLLMENT BY MONTH
















Age of VEP

To ensure that it is being consistent and efficient, the commission has requested quarterly updates on out-of-state travel, licensing matters, and illegal gambling efforts.

I. OUT-OF-STATE TRAVEL


III. ILLEGAL GAMBLING

The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,649 total illegal gambling-related questions or complaints from the general public. During the second quarter (Q-2) of 2024, the Commission received seventeen (17) calls and emails from the general public, down eight (8) from the previous quarter and down twenty-one (21) from the second quarter of 2023.

Of the seventeen (17) calls and emails received in Q-2, sixteen (16) involved slot machines and one (1) involved quarter pushers.

Breakdown of illegal gambling inquiries and complaints to-date:



The above chart does not reflect calls and activity related to the following:

- Reports made to KRGC agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGC can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.
- Inquiries from the public that are answered through access to KRGC's Illegal Gambling Frequently Asked Questions (FAQs) web page.
- During the second quarter of 2024, KRGC agents assisted in a multi-agency seizure in Leavenworth County. The collaborative effort between the KRGC, Leavenworth Police Department, and the Lansing Police Department resulted in the seizure and forfeiture of eight gambling devices and over \$14,000 of illegal gambling proceeds.

KRGC updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGC began tracking the new page, there have been a total of 25,502 unique page views (after adjustments). A total of 751 unique page views were made during the second quarter of 2024, down 245 from the previous quarter (adjusted) and down 47 from the second quarter of 2023 (adjusted).
