MINUTES – DECEMBER 13, 2024

CALL TO ORDER

(A.)

Chairman David Moses called the December 13, 2024, meeting to order at 10:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites and the agency's social media pages.

Commissioners Brandon Jones and Mike Fleming were also present. Others present included Executive Director Don Brownlee, General Counsel Judith Taylor, Director of IT&C-s Dennis Bachman, Director of Security Roger Bailey, Director of Sports Wagering and Licensing DJ Lopez, Director of Casino Operations Rick Wilson, Government Relations Managers Randy Evans, and other staff. Commissioner Turnquist was unable to attend the meeting.

MOTION, APPROVE AGENDA

Commissioner Fleming (Jones) moved to approve the agenda. Motion carried 3-0.

MOTION, APPROVE NOVEMBER 15, 2024 MEETING MINUTES

(C.)

Commissioner Jones (Fleming) moved to approve the minutes of the November 15, 2024, meeting. Motion carried 3-0.

MOTION, APPROVE CONSENT AGENDA

Commissioner Fleming (Jones) moved to approve the consent agenda (six items). Motion carried 3-0.

LOTTERY GAMING FACILITY REPORTS/ITEMS; BOOT HILL CASINO & RESORT

(E.1.a.)

Diane Giardine, General Manager, reported:

- That December 15th will be the facilities 15th opening anniversary.
- November 2024 revenue numbers compared to November 2023:
 - Total gaming revenue increased 5.24%
 - Total slot revenue was up 8.67%
 - Table games revenue was down 20.62%
- General Manager Giardine explained that table games revenue was down due to a hold issue. Prior year's hold percentage was in the mid-twenties, which is phenomenal, and this year it was just below twenty.
- General Manager Giardine highlighted that the carpet improvement project was completed. The project impacted October's revenue, but November's revenue came back. General Manager Giardine thanked all involved with the project.
- November 2024 Sports Wagering revenue numbers
 - Retail Sportsbook Revenue \$43,772.00
 - Up 4,219.80% from November 2023
 - Handle was down about 28%, but hold was up 3,900%.
 - Digital Sportsbook Revenue: \$12,524,998.00
 - Up 197.79% from November 2023
 - This is a new revenue record for the facility, the previous record was set in September 2024.

- Handle was up 16%, which was also a new record; the previous highest month was October 2024. Hold was up 158%, which was also a record beating July 2023
- Top Events
 - Eagles vs Rams
 - Texas vs Texas A&M
 - Cardinal vs Seahawks
- Top Sports
 - NFL was 31% of handle.
 - NCAA Football was 26.7% of handle.
 - NCAA Basketball was 25.9% of handle.
- Commissioner Fleming asked what the total digital sportsbook revenue for October was. General Manager Giardine responded that revenue was close to negative. Commissioner Fleming asked what the General Manager attributes November's banner month to. General Manager Giardine explained that when the Chiefs do not cover the point spread the sportsbook does very well.

- Chairman Moses recalled that in the south-central Kansas media markets the smokeless casino legislation is getting a lot of chatter. The facility just finished a major remodel that depending on how the legislation is written, may need to be redone. Chairman Moses asked General Manager Giardine if they would like to comment on this topic. General Manager Giardine deferred to the facility's CEO and legal counsel; Chris Reedy. Mr. Reedy explained that hundreds of thousands of dollars were spent on the air handling equipment and original design, there are areas of non-smoking, there are all sorts of planning and thought process going out with respect to that matter. Chairman Moses followed up stating that he presumes that means there will be some attempts at educating those that are going to be considering changes about all the things that have already been done regarding that issue. Mr. Reedy confirmed that was accurate. Chairman Moses commented that he was curious because it seems that there is significantly more attention this year than last year. General Manager Giardine commented that if any employee has a request the facility will work with them; there are several positions that do not have to be in the

smoking area. The facility would make a medical accommodation request for the employee and go through that process.

- General Manager Giardine recognized a few individuals for their actions on December 2nd. Beverage Lead Michael Montoya, Director of Security Zam Marvilla, KRGC Agent Michael Robbins, and KRGC Agent Eric Lalicker recognized a patron in need and took swift steps to help that patron. Agent Robbins used a AED machine and started performing CPR compressions on the patron, Director Marvilla switched out with Agent Robbins to continue the CPR until first responders were able to arrive. The patron was transported to Dodge City Hospital and eventually transferred to a hospital in Colorado where the patron was from. Last Friday, the facility was contacted by the patron's daughter thanking all who were involved in saving her father's life. The doctor in Colorado said that if CPR had not been started as quickly as it had, her father would not have survived.

Alli Kuplen, General Manager, reported:

- November 2024 revenue numbers compared to November 2023:
 - Total gross gaming revenue was up 15.5%
 - Total slot revenue up 9.7%
 - Table games revenue up 35.1%
 - Table games hold was at 24% which contributed to increase.
- November 2024 Sports Wagering revenue
 - Retail Sportsbook Revenue \$237,500.00.
 - Up compared to November 2023's revenue of \$57,000.00.
 - Digital Sportsbook Revenue: \$8,670,000.00
 - Up from November 2023's revenue of \$1,800,000.00.
- November 2024 Sports Wagering
 - \$96 million was wagered on FanDuel online.
 - The total handle in retail was \$1.525 million for November.
 - Football once again ruled the betting in retail as College Football had 45% of the total handle followed by the NFL with 39%. They were followed by College Basketball at 6%, NBA at 4%, NHL at 2%, MMA at 2% and Boxing at 1%.
 - The Kansas City Chiefs game on Black Friday brought a huge crowd in as it was only available on Prime Network.
 - The Mike Tyson/Jake Paul boxing event on 11/15 brought in one of the largest crowds that we have ever seen at FanDuel Sportsbook at KSC. The event brought in a handle of \$13,626 with 281 total bets.

- General Manager Kuplen stated that would like to echo what was said by Mr. Reedy. General Manager Kuplen noted that commissioners have visited the facility and would be surprised if they noticed smoke anywhere. The facility has state of the art air handling systems, dedicated non-smoking area, there is no smoking at table games, restaurants, or sportsbook. General Manager Kuplen stated that they felt that unless you are next to a smoking patron, that smoke impacts guest experience. Any team member with concerns can ask for accommodations if one is needed, and the facility manager is happy to provide one. Chairman Moses noted that he senses this time around that employee exposure to second-hand smoke is more of the focus and asked if General Manager Kuplen also had that sense. General Manager Kuplen responded stating that she thinks that generally in the nation people are more conscious. General Manager Kuplen commented that she has worked on the property since opening, has asthma, and has not had an issue with smoke.

Lydia Garvey, General Manager, reported:

- November 2024 admissions were up 4.8% compared to November 2023
- November 2024 revenue numbers compared to November 2023:
 - Total gross gaming revenue increased 14.6%
 - Slot revenue increased 14.7%
 - Table games revenue increased 13.8%
- November 2024 Sports Wagering revenue numbers
 - Retail Sportsbook Taxable Revenue: \$818,046.00
 - Up 79.4% compared to November 2023
 - Due to both increased handle and favorable hold. Handle was up 45%.
 - Retail Sportsbook: Top Sports
 - NFL was 35% of handle
 - NCAA Basketball was 27% of handle
 - NCAA Football was 19% of handle
 - Digital Sportsbook Taxable Revenue: \$841,750.00
 - Up 122.6% compared to November 2023
 - Handle was down 43% compared to prior year.
 - Digital Sportsbook: Top Sports
 - NFL was 33% of handle
 - NCAA Basketball was 25% of handle

- The facility manager held a hiring event targeting those positions that have recently been approved to hire between eighteen and twenty-one years of age. Hiring events typically have around 200 people RSVP and about 50 people show up, this event had 300 RSVP with 90 actually attending and close to 50 job offers.
- General Manager Garvey said that their position is very similar to the previous two facility managers. State of the art air handling systems ensure that the facility is not smokey and accommodations are available for team members who request them. There are non-smoking slot areas, sportsbook, and restaurants.
- Chairman Moses asked if the Women’s Soccer National Championship caused a bump in business. General Manager Garvey explained that the facility did not see a impact for that event, but there is an expectation for the 2026 World Cup to have a lot of impact because of the proximity. Chairman Moses followed up by asking if they will use both facilities as well as Arrowhead Stadium. General Manager Garvey confirmed they will.

Scott Beeler, Golden Circle Representative, reported:

- Construction is winter-tight. Now working on electrical, plumbing, duct system, and the internal wall systems.
- The project is on budget and on time for a late 2025 opening.
- A lot of the contracts are still in negotiation and will be submitted to staff once there are signatures on them.
- Regarding the Chairman's question on the smokeless casino legislation, the facility licensee is in a different situation for a number of legal reasons, but they believe there is some ambiguity in the law. The facility is designed in terms of its construction to have the proper handling systems in the event that the facility is deemed to fit within one of the exceptions under the Clean Air Act. Mr. Beeler explained that at the time the Clean Air Act was enacted there was no such thing as a Historical Horse Racing facility, but believes that the spirit of the act in terms of granting exceptions was for gaming facilities.

Employees

During the second half of 2024, Kansas Star Casino processed 143 new team members through new hire orientation. All received the following training courses as part of orientation:

- Responsible Gaming with special emphasis on underage awareness and an overview of the Voluntary Exclusion Program
- Alcohol Awareness

In addition, team members are subject to a more intensive alcohol awareness training program called, ServSafe. Team members that are trained includes:

- All Front of House Food and Beverage managers and team members that participate in the serving of alcoholic beverages.
- All Security Staff
- All Valet Staff
- Slot Floorperson and above
- Table Games Dealers and above
- Surveillance Staff
- All Directors

ServSafe is a three-hour course with a test at the end which team members must pass with at least a 75% score. In the second half of 2024, 135 team members took and passed the ServSafe training, and 0 team members failed and were required to re-take the training until they received a passing score.

All training is done online with website 360training.com.

The Kansas Star Casino Responsible Gaming trainers are:

- Alecia Pray, Director of Human Resources
- Miranda Fields, Human Resources Manager
- Marlene Rivera, Senior Human Resources Specialist

As of December 31, 2024, Kansas Star Casino had 620 active team members.



Ongoing Training

In addition to the training given in new hire orientation, all Kansas Star Casino team members undergo annual refresher training in Responsible Gaming. To make training more accessible we have the Responsible Gaming training module online in our suite of Skillsoft courses.

The total amount spent on responsible gaming materials was \$1728.15, which was spent on ServSafe training, online services.

Daily Application

While all departments and team members are actively involved in preventing underage, intoxicated and self-excluded patrons from entering the casino floor and from gambling if they do gain access, the Security Officers stationed at the gated entrances are the primary method of prevention. Security follows the property's policy of checking IDs for people who appear 30 or younger; the statistics for these ID checks during the second half of 2024 are:

- Underage individuals denied gaming floor access: 184
- People denied access for not having ID: 489
- People denied for invalid ID: 330
- Intoxicated individuals denied gaming floor access: 127
- VEPs denied access to the gaming floor: 10

Further, there were 260 intoxicated individuals ejected from the casino, 11 VEPs were removed and turned over to the KRGC and the Mulvane Police Department, and 1 underage person were caught and ejected from the casino. Also, 135 persons were removed and 23 excluded from the casino for a variety of reasons.

During the second half of 2024, there were 609,391 guests who entered the casino floor. Security team members checked 91,492 IDs. In addition, 106 ID checks took place on the gaming floor in situations involving suspected minors.

Several other ongoing efforts are noteworthy as the Kansas Star Casino is an active member and participant in the Kansas Coalition on Problem Gambling, Problem Gambling Program Committee, and the South-Central Task Force on Problem Gambling.

July 1, 2024 thru December 31, 2024

1. Employees

At the end of the reporting period, Hollywood Casino had a total of 472 employees. During the reporting period, 151 employees were hired.

2. Responsible Gaming Training:

All employees hired during the reporting period received initial training on responsible gaming during property orientation. This consisted of approximately 30 minutes dedicated to responsible gaming. All employees successfully completed this training.

Of those new hires, 39 were hired into positions which require additional training to understand the proper procedures for responsible alcohol service. All of those employees successfully completed the TiPS training.

In addition, there were 13 existing employees who successfully completed refresher TiPS training and 7 employees that transferred into new positions that required them to be TiPS certified.

3. Statistics:

To assist in tracking the success of the Responsible Gaming Plan, Hollywood Casino maintains statistics related to responsible gaming. Some of the numbers from the reporting period include:

- Hollywood Casino refused entry to 54 minors who attempted to gain access to the property.
- There were 3 minors who successfully gained access to the casino during the period.
- In addition, Hollywood Casino either refused entry to or removed from the property 170 individuals who appeared to be under the influence of alcohol.
- In addition to training officers to be observant at the casino entrances, Hollywood Casino has procedures in place to identify VEPs when they attempt to cash a check, perform a cash advance, attempt to claim a taxable jackpot, or attempt to create a Penn Play (player club) account. During the reporting period, Hollywood Casino discovered 13 VEPs on property. The local KRG Agent on Duty was contacted immediately in each of these instances and took custody of the VEP for processing.

She also represents KCC at the monthly meetings for the Southeast Kansas (SEKS) Problem Gambling Task Force.

Kansas Crossing participated in Responsible Gambling Education Month in September 2024. KCC had activities to improve team member knowledge and stress the importance of Responsible Gambling for the casino and the community.




Voluntary Exclusion Report

Total Number of Exclusions




Age of SWEP




Active Sports Wagering Exclusion Durations



SWE Enrollment by Platform*







SPORTS WAGERING EXCLUSION ENROLLMENT BY MONTH




Voluntary Exclusion Program **January 2010 –December 2024**


II. ILLEGAL GAMBLING

The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,694 total illegal gambling-related questions or complaints from the general public. During the fourth quarter (Q-4) of 2024, the Commission received twenty (20) calls and emails from the general public, down two (2) from the previous quarter and up four (4) from the fourth quarter of 2023.

Of the twenty (20) calls and emails received in Q-4, eighteen(18) involved slot machines; one (1) involved raffles; and one (1) involved other types of gambling. The one (1) other call received, involved sports wagering.

Breakdown of illegal gambling inquiries and complaints to-date:



The above chart does not reflect calls and activity related to the following:

- Reports made to KRGC agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGC can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.
- Inquiries from the public that are answered through access to KRGC's Illegal Gambling Frequently Asked Questions (FAQs) web page.

KRGC updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGC began tracking the new page, there have been a total of 26,958 unique page views (after adjustments). A total of 788 unique page views were made during the fourth quarter of 2024, up 120 from the previous quarter (adjusted).
