MINUTES – SEPTEMBER 12, 2025

CALL TO ORDER (A.)

Chairman David Moses called the September 12, 2025, meeting to order at 9:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites and the agency's social media pages. Commissioners Larry Turnquist and Brandon Jones were also present. Others present included Executive Director Don Brownlee, Director of Security Roger Bailey, Director of Gambling DJ Lopez, Director of Casino Operations Rick Wilson, and other staff. Commissioner Mike Fleming was absent due to a scheduling conflict.

MOTION, APPROVE AGENDA (B.)

Commissioner Turnquist (Jones) moved to approve the agenda. Motion carried 3-0.

MOTION, APPROVE August 15, 2025 MEETING MINUTES (C.)

Commissioner Jones (Turnquist) moved to approve the minutes of the August 15, 2025, meeting. Motion carried 3-0.

MOTION, APPROVE CONSENT AGENDA (D.)

Commissioner Turnquist (Jones) moved to approve the consent agenda (seven items). Motion carried 3-0.

LOTTERY GAMING FACILITY REPORTS/ITEMS; BOOT HILL CASINO & RESORT (E.1.a.)

Ryan Deutsch, General Manager, reported:

- August 2025 revenue numbers compared to August 2024:
 - Total gaming revenue decreased 0.33%
 - Total slot revenue was down 0.75%
 - Table games revenue was up 3.16%
- August 2025 Sports Wagering revenue numbers
 - Retail Sportsbook Revenue \$33,351.00
 - Up 129.54% from August 2024
 - Handle was \$231,476 up 7.57%
 - Hold was up 113.45%
 - Digital Sportsbook Revenue: \$5,412,453.00
 - Up 92.91% from August 2024
 - Handle was \$76,205,331.00 up 12.60%
 - Hold was up 51.39%
 - For the Chiefs opener in Brazil 88% of the spread bets were on the Chiefs.
 - There was a five-leg parlay on Chiefs props that paid nearly \$7,000.
 - For as good as the Chiefs opener was for the facility, the Sunday night Bills v Ravens was just as bad if not worse. Bills covering, the over hit, and all of the popular players for parlay bets scored touchdowns and hit their overs.

- Chairman Moses noted the flurry of media about the NCAA investigation of student athletes and fixing of games and asked if the facility has any type of liaison or coordination with NCAA and does it reach to the level of what we offer in the way of sports gaming. General Manager Deutsch said that the question might be better answered by KRGD Director of Gambling DJ Lopez. Chairman Moses followed up asking if the facility has a safeguard built in that if a student athlete is recognized in the retail sportsbook is there any kind of warning sign or proactive action taken. General Manager Deutsch said that he thinks there is, noting that on the retail sportsbook side it is probably easier to see faces and recognize people. The facility has an across the board “see something, say something” policy. On the digital side, that would be a better question for the platforms. Chairman Moses asked if the facility has a working relationship with the higher education facility in the community to do education of student athletes regarding sports

wagering and related problems, and if not, has the facility considered creating something like that. General Manager Deutsch responded that he has a good relationship with the Athletic Director at the local college noting that when the legislature was discussing sports wagering, he knows that the college's board had some discussions about education for the athletes. General Manager Deutsch said he does not know the specific program they have but he knows there have been discussions about it. Chairman Moses asked that each facility manager address these questions.

Alli Kuplen, General Manager, reported:

- August 2025 revenue numbers compared to August 2024:
 - Total gross gaming revenue was increased 6.2%
 - Total slot revenue up 11.93%
 - Table games revenue down 24.27%
 - General Manager Kuplen noted that table games volume was great but there were two big progressive jackpots on the linked Carnival Games progressive. The mega jackpot of \$306,000.00 was won on Mississippi Stud in August, the major jackpot of \$82,000.00 was won on Ultimate Texas Hold 'Em.
- August 2025 Sports Wagering revenue
 - Retail Sportsbook Revenue \$128,400.00
 - Up compared to August 2024's revenue of \$92,500.00
 - Digital Sportsbook Revenue: \$4,020,000.00
 - Up from August 2024's revenue of \$2,600,000.00
 - Handle was \$64,450,000.00
- August 2025 Sports Wagering
 - The total handle in retail was \$760k for August. This was up over \$250k from July.
 - The handle was led by College Football at 57%. This was followed by Baseball at 17%, NFL Preseason at 13%, UFC at 11% and Soccer, Tennis and Golf rounded at the handle.
 - The largest wager in retail in August was a \$17,000 bet in college football on the Oklahoma Sooners -39.5 over Illinois State. This wager was a loss.

- Chairman Moses asked if General Kuplen could speak to the remodel. General Manager Kuplen explained that the facility has started construction on a “Entertainment Zone” on the casino floor. A long bar and lounge space with a small stage that will allow the facility to play music videos, have DJs, small bands, trivia, and karaoke. With this, the facility is expanding their gaming floor to the hotel lobby.
- General Manager Kuplen explained that there is not a casino-lead program at Wichita and there is an opportunity there to connect with them and educate their student athletes.
- Commissioner Turnquist asked if this was the first state fair where the facility had a booth. General Manager Kuplen explained that the facility had a booth last year but not in the same capacity. This year the facility was present every day of the state fair.

- General Manager Garvey reported that on Monday the facility presented the preliminary design concept for the hotel to the Unified Government’s planning commission and received unanimous approval. The next step is that on the 25th the facility will go before the full commission meeting of the Unified Government and pending that approval General Manager Garvey will have some information to share. Chairman Moses asked if that would be when the commission learns who the flag for the hotel is. General Manager Garvey responded that she was not sure about that; however, the facility is looking at two options and regardless which is picked she believes that Chairman Moses will be happy with the flag.
- General Manager Garvey said no to all of the questions regarding the NCAA, also noting that team in the sportsbook, anecdotally, is pretty good about noticing things they are aware of. The facility had a random very specific bet regarding the NFL draft made by someone who has the same last name as an NFL coach, a full investigation was done into that. It turned out to be nothing, but the team knows their sports, pays attention, and brings it up. Chairman Moses commented that he is a big advocate of being proactive and educational but having said that and working on matters involving the NCAA in his prior life, he is aware that they are not always receptive to outsiders. However, Chairman Moses encourages all of the facility managers to consider reaching out to the various higher education institutions in your area, they may welcome it.

- General Manager McKain reported that while the facility does have relationships and partnerships with Pittsburg State University the facility does not have any direct programs for sports wagering and athletes. If facility staff see anything on the casino floor, in the sportsbook or not, that is brought up. It is actually a KRGC requirement that the facility reports anything believed to be illegal.

Scott Beeler, Golden Circle Representative, reported:

- Mentioned last time that they are receiving weekly construction progress reports. This last week there were 27 line items that were relative to the interior finish and 24 line items pertaining to landscape site work. It is interesting to Mr. Beeler that there were no items relating to work on the exterior because all of that work is finished. Mr. Beeler noted that one of the interior items was work on the mechanical bull.
- The facility is aiming at an official grand opening for December 15th. Mr. Beeler welcomed the commissioners to attend the grand opening. Mr. Beeler was confident that Gilley's would like to have the chairman make comments if available.

Brandi White, Director of Administration, Audit, and Finance presented the fiscal year 2026 and 2027 annual budgets on behalf of KRGC.

Commissioner Turnquist asked if Executive Director Don Brownlee had any comments regarding Director White's budget presentation. Executive

Director Brownlee commented that he supports Director White's recommendations totally.

Chairman Moses asked if KRGC staff anticipated live horse racing in the proposed budgets, and if so, did KRGC have to make any additional increases because of that. Director White responded that realistically the earliest possible live racing will occur in the Fall of 2026. If live racing occurs in the Fall of 2026, then the agency will have another opportunity to revise the fiscal year 2026 budget in September of 2026. Likewise, if live racing occurs in the spring of 2027 the agency will include the revision at that time. If there is a county fair in the spring of 2026, KRGC is a no limit fee fund, and it is designed that way, so the agency does not impede business. The agency will have authority to regulate fair racing if that happens.

Chairman Moses asked if the legislature were to take action that impacts the sports wagering contracts that action, or inaction, would have nothing to do with KRGC budgets. Director White confirmed that was accurate.

Brandi White, Director of Administration, Audit, and Finance presented the fiscal year 2026 and 2027 annual budgets on behalf of the Kansas State Gaming Agency.

Chairman Moses asked if the expansion of the facility in Wichita would impact any budget needs. Director White responded that only when there is a successful renegotiation of the compact will the budget need revised. Chairman Moses asked if the \$200M expansion required a negotiation. Director White responded that it did not because the facility manager is not under compact, however they are currently negotiating the compact. Kansas State Gaming Agency Executive Director Kala Loomis explained that the facility is a class 2 facility which is not regulated by KSGA and is not under compact but rather is covered by the National Indian Gaming Commission. Executive Director Loomis noted that would change if the compact is negotiated. Chairman Moses asked if this major of an expansion would not mean more lifting on KSGA's part. Executive Director Loomis explained that the agency will have to get more employees but as far as anything else that is not part of the compacts KSGA will not have any say of expansions or anything like that.

Chairman Moses asked if there were some compact negotiations regarding mobile sports wagering. Executive Director Loomis responded that is still out there and there is also a Florida court case, when they originally negotiated language was put in, prior to court case rising to the appellate court, and it does not quite cover what needs to be covered for how the appeals court decided that and right now they are still sitting on that. Executive Director Loomis said she has heard nothing about going anywhere as far as mobile. Chairman Moses asked if it does would that put extra weight on KSGA. Executive Director Loomis confirmed it would and that was the reasoning behind the extra positions. Chairman Moses asked if KSGA was similar to KRGC in that if more funding is needed, they would be able to adjust or if the agency is structured differently. Executive Director Loomis explained that the agency is structured differently because they would need to go to the tribes and get approvals and the only timeframe to do that is the August timeframe. Executive Director Loomis explained she was not sure how that would play out and that the agency would need to talk to the Governor's Office, the Attorney General's Office, and the agency's legal department to determine how the agency would address that because it is not addressed in the compacts. Chairman Moses asked if that part of that issue could be handled by the timing of when any new compact goes into effect. Executive Director Loomis confirmed that was accurate noting that it might be easier for the agency to wait until the next fiscal year and then make a request. Matter of fact, by compact that is probably the only avenue the agency has right now.

Chairman Moses noted that he saw the tease of an article about how many tribes are in Kansas and how many have casinos and asked if Executive Director Loomis thought the commission would benefit from reading the article. Executive Director Loomis responded that the article was covering basic information and that the commission would likely not find any new information.

Todd Allen, Kansas Racing and Gaming Commission financial investigator, presented the staff agenda memorandum regarding the Kansas Crossing Casino material debt transaction approval request. Mr. Allen recommended that the commission approve the material debt transaction.

APPROVAL REQUEST
(G.5)

Kevin Fowler, attorney with Frieden & Forbes, representing Peninsula Pacific Entertainment Development, the parent company of the facility manager for Kansas Crossing Casino, further explained the transaction approval request. Dustin Manternach, Chief Financial Officer for Peninsula Pacific Entertainment Development, LLC, assisted with the presentation and questions.

Chairman Moses noted that during the presentation it was referred to as an unincumbered note and asked if it were really a transfer of incumbering. Mr. Manternach responded that was accurate, both Kansas and New Hampshire would be guarantors under the note. Chairman Moses asked what Kansas was guaranteeing in the event of default, what is Kansas risking. Mr. Manternach explained that Kansas has the same obligation as New Hampshire and Iowa, everybody is under the same. Mr. Manternach further explained that right now Kansas' principal payments annually under the current debt is \$4M, just for Kansas, under the new agreement it is a \$4M payment covered by all three locations. Mr. Manternach noted that geographical diversification is also a benefit. Chairman Moses summarized that there is risk, but the risk is now being shared with others that are in the same bed as Kansas. Mr. Manternach said that was accurate. Chairman Moses noted that it is a financial risk but asked if Kansas is securing the transaction with anything at all. Mr. Manternach explained that if the company were to default the facility's assets could be turned over. Chairman Moses noted that those would be the assets of the facility not the assets that belong to Kansas. Mr. Manternach confirmed that was accurate.

Commissioner Turnquist asked if there were just three facilities that were impacted by this transaction. Mr. Manternach explained that there are three states, but New Hampshire has five facilities, all seven facilities will be impacted.

Chairman Moses asked Staff Attorney James Bain if he had reviewed the contract and if the "magic language" that appears is appropriate. Staff Attorney Bain confirmed he reviewed the contract and the language was appropriate.

Commissioner Turnquist asked if General Manager Jeff McKain has any comments or thoughts about the transaction. General Manager McKain said that his job is the safe operations of the Kansas Crossing Casino and that he has had little to no participation in this financial transaction.

Commissioner Turnquist noted that the commission has considered the Kansas Crossing Casino material debt transaction and believes the transaction would not deprive the facility manager of financial stability, nor would it adversely affect the financial condition of the Kansas Crossing Casino or negatively impact or cause default on Kansas Crossing Casino, or the gaming facility manager. Commissioner Turnquist (Jones) moved to approve the Kansas Crossing Casino material debt transaction.

STAFF REPORTS
(I.1. and I.2.)

Garrett Rogers, Paralegal, reported on both the Voluntary Exclusion Program and Sports Wagering Exclusion Program statistics for August 2025.

- Mr. Rogers noted that at the last meeting he presented the 2025 Gambling Survey Executive Summary and was asked a question about how respondents learned of the survey and he did not have a great answer. Mr. Rogers explained that the survey was not public and that the Learning Tree Institute contracted with a market research group for a purchase panel of respondents. The only screening questions used were whether the respondent was a Kansas resident and whether they were 18-years of age or older. Chairman Moses asked if we know unbiased or objective the group was that was surveyed. Mr. Rogers explained that he does not know the market research group that was contracted.

Executive Director Brownlee reported:

- The reconstructed Docking State Office Building will have a ribbon cutting on October 30th. The agencies moving to that location are Secretary of State, Department of Commerce, State Budget Office, State Personnel Office, and Capitol Police. There will also be conference rooms that state agencies can reserve and use if needed.
- KRGC has made conditional offers of employment to the balance of the intended KRGC staff members to the Gilley's facility.
- There is a legislative hearing regarding sports wagering revenue later this month. The Lottery will have the bulk of the testimony. KRGC will be there to address any questions that might overlap. KRGC is working with the Lottery on any kind of address. KRGC has been asked to have a representative present to address questions regarding responsible gaming Garrett Rogers will be attending to address any questions having to do with responsible gambling programs.

- Chairman Moses asked Government Relations Manager Randy Evans if the hearing will be streamed online. Mr. Evans confirmed it would be.
- KRGC continues to meet with horse racing groups to gather information relevant to horse racing start up. Currently KRGC, plans to present to the commission issues such as what constitutes a Kansas-Bred horse. There are varying opinions on how KRGC should move forward. KRGC will be asking the commission to make a decision on that during the October meeting.
- The next commission meeting is scheduled for October 18th at 10:00a.m. at the Kansas Star Casino.
- Chairman Moses asked where the agency is with coordinating the December meeting with a tour of the finished Gilley's. Executive Director Brownlee responded that no arrangements have been made yet. The discussion earlier this morning about doing that in conjunction with the December meeting is fine with KRGC. Chairman Moses noted that he thinks it would be great to do it as close to the grand opening as possible, however it would not make sense to do it on the grand opening. Executive Director Brownlee said that the December meeting is scheduled for December 12th and that KRGC staff would work with Gilley's to see if that will work with them.

STAFF AGENDA MEMORANDUM

DATE OF MEETING: October 17, 2025

AGENDA ITEM: **Commission Discussion/Action on Requested Regulation Changes with Regard to Live Horse Racing**

PRESENTER: D.J. Lopez, Director of Gambling, Racing and Gaming Commission

ISSUE SUMMARY: With the anticipated return of parimutuel wagering on live horse racing in the State of Kansas. Industry stakeholders approached KRGC staff requesting a number of changes to the Administrative Rules and Regulations Governing Live Racing.

Over the past few months, industry stakeholders have worked with their respective associations and presented staff with a number of requested changes. While stakeholders agree on some changes they continue to negotiate on other changes.

One specific regulation change that stakeholders continue to work through is Article 12 (Kansas Horse Breeding Development Fund). Article 12 is a regulation that governs the state's breed registry.

As December and January, which is foal season, approaches, implementing changes to Article 12 becomes time sensitive. With industry stakeholders continuing to navigate changes to Article 12, it is evident that regulation changes will not be completed and submitted through the state process by that time.

Once stakeholders have had the opportunity to reach an understanding and finalize changes to Article 12, along with changes to additional Articles, KRGC staff will review the changes and work with stakeholders to make edits to the regulations and submit said changes through the state process.

In keeping with commission protocol, staff has reached out to stakeholders requesting anyone wishing to address the commission on live horse racing topics to provide written statements, which have been forwarded to commissioners for review.

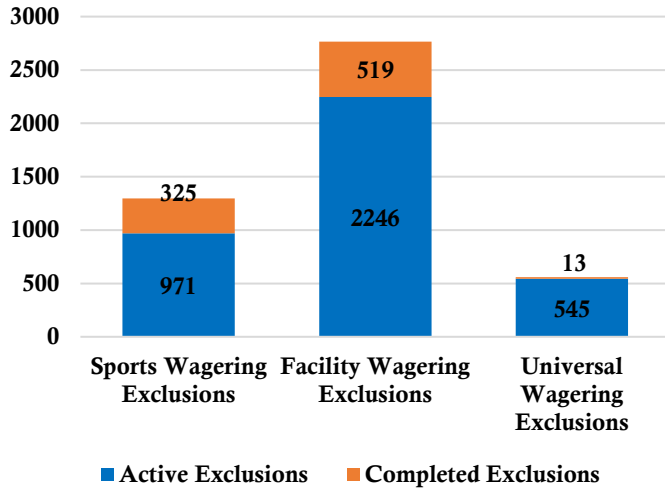
Staff recommends leaving current regulations as is and continuing to operate under the established guidelines.

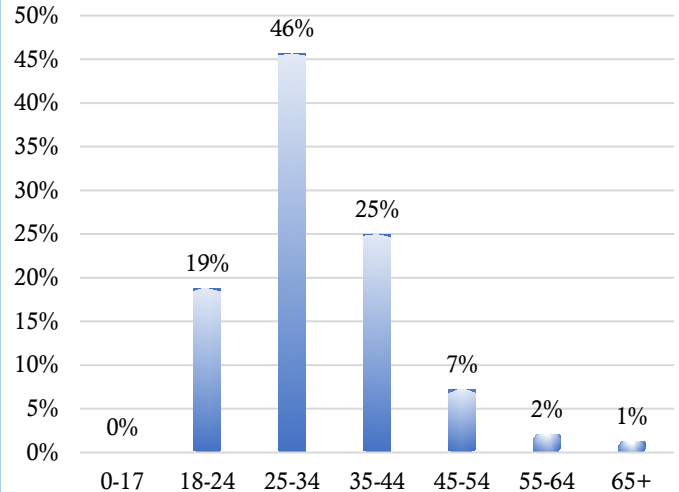

Total Number of Exclusions

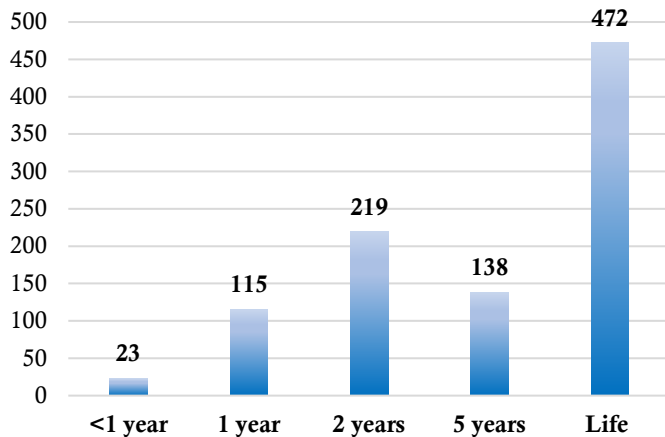


Age of SWEP

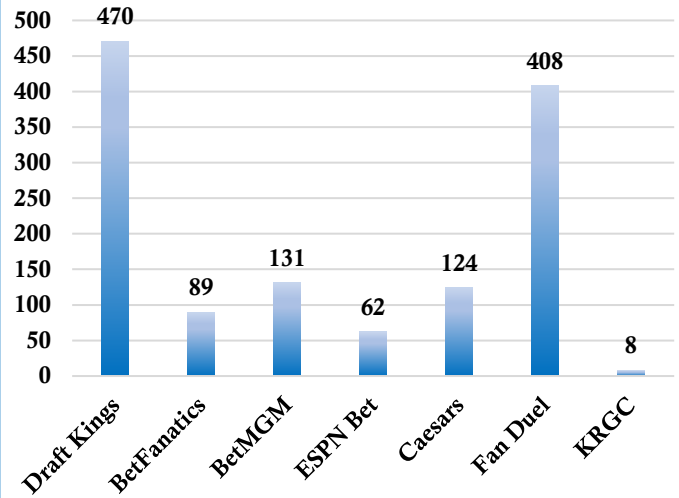


Active Sports Wagering Exclusion Durations

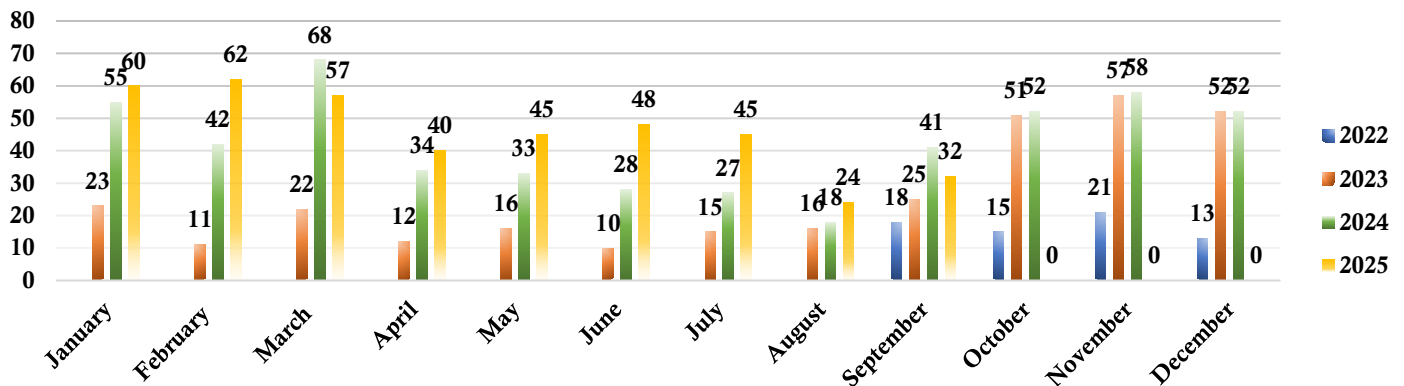

SWE Enrollment by Platform*



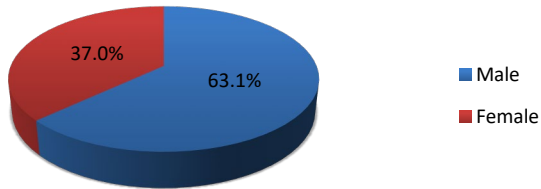
SPORTS WAGERING EXCLUSION ENROLLMENT BY MONTH



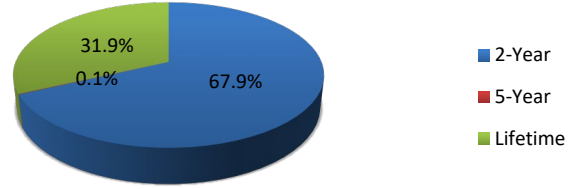

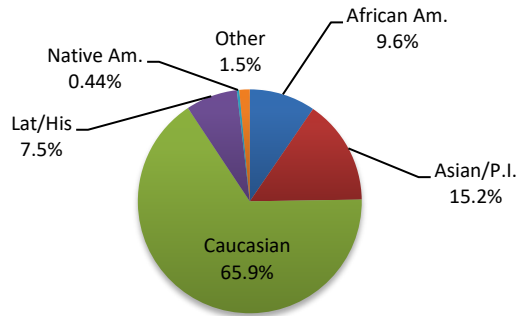

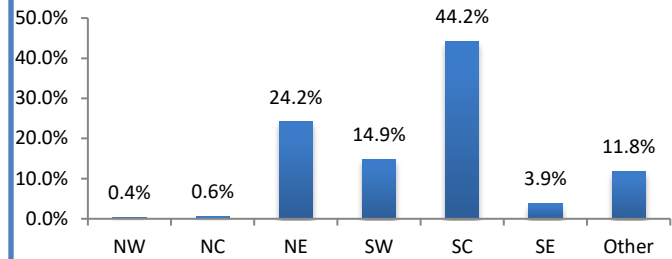

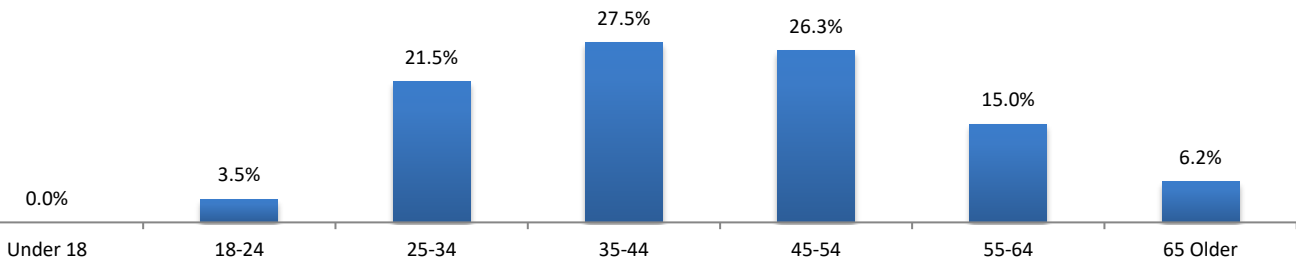

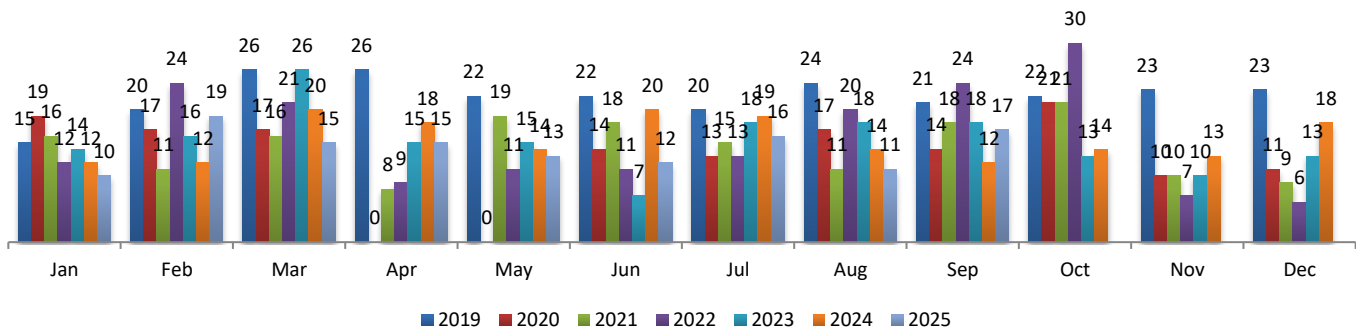

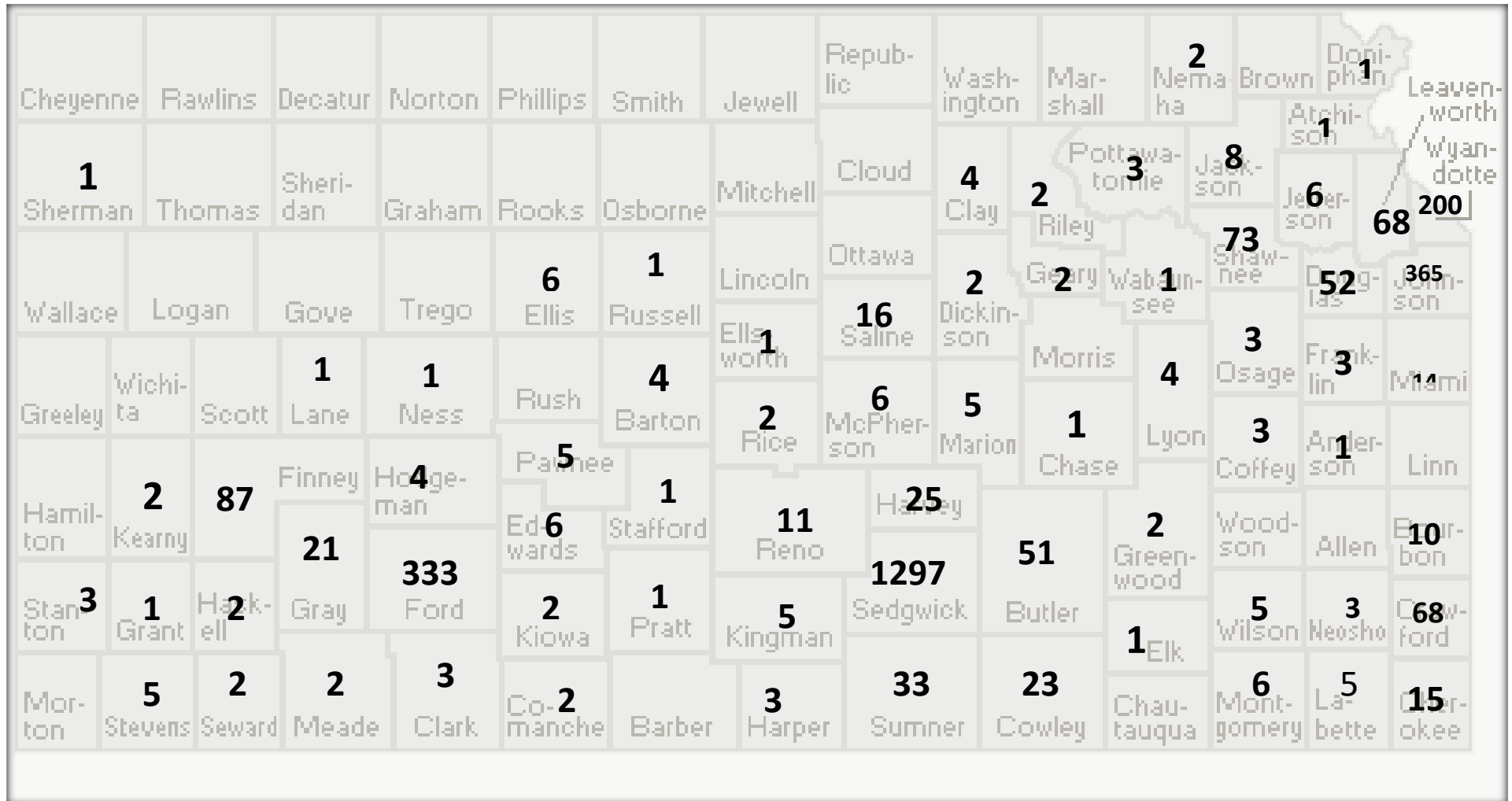
Age of VEP

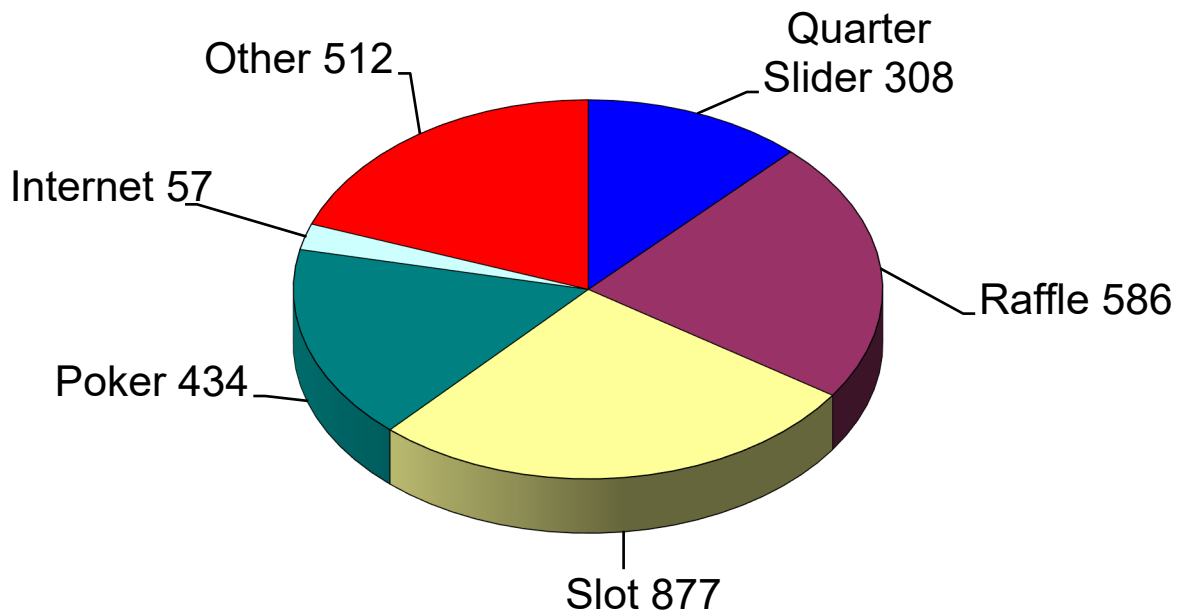
III. ILLEGAL GAMBLING

The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,774 total illegal gambling-related questions or complaints from the general public. During the third quarter (Q-3) of 2025, the Commission received thirty (30) calls and emails from the general public, up five (5) from the previous quarter and up one (1) from the third quarter of 2024.

Of the thirty (30) calls and emails received in Q-3, twenty-eight (28) involved slot machines and two (2) involved raffles.

Breakdown of illegal gambling inquiries and complaints to-date:



The above chart does not reflect calls and activity related to the following:

- Reports made to KRGc agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGc can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.
- Inquiries from the public that are answered through access to KRGc's Illegal Gambling Frequently Asked Questions (FAQs) web page.

KRGc updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGc began tracking the new page, there have been a total of 29,653 unique page views (after adjustments). A total of 577 unique page views were made during the third quarter of 2025, down 390 from the previous quarter (adjusted) and down 91 from the third quarter of 2024 (adjusted).
