MINUTES – DECEMBER 12, 2025

CALL TO ORDER (A.)

Chairman David Moses called the December 12, 2025, meeting to order at 10:00 a.m. The meeting was held at the Eisenhower State Office Building in Topeka, Kansas. Notice of this meeting was given to the public via the KRGC and Public Square websites and the agency's social media pages. Commissioners Brandon Jones, Larry Turnquist, Mike Fleming, and Natalie Haag were also present. Others present included Executive Director Don Brownlee, Director of Administration, Audit, Budget, and Finance Brandi White, Director of Security Roger Bailey, Director of Gambling DJ Lopez, Director of Casino Operations Rick Wilson, Government Relations Manager Randy Evans, IT Director Dennis Bachman and other staff.

Chairman Moses congratulated James Bain on the recent announcement that he has been hired as General Counsel for KRGC.

Jason Watkins, representative of Gilley's, reported the following:

- The facility opened Monday, December 15th with the Grand Opening on December 31st. Mrs. Gilley will be visiting the location and making some comments.
- There is a story in today's Wichita Eagle that has some video and pictures of the facility. Mr. Ruffin and his team have done an incredible job, and it is so much more than a gaming facility. The inside is done and ready to go. There is still some stuff to be done outside, the pickle ball courts.
- The concerts are selling out.
- They are excited to be able to report revenue figures in January.
- Chairman Moses noted that the facility's social media campaign is very effective, and he believes that locals are excited. Mr. Watkins agreed that the response on social media has been very positive.
- Chairman Moses noted that the next month's meeting would be held at Gilley's.

STAFF REPORTS
(I.1. and I.2.)

Garrett Rogers, Paralegal, reported on both the Voluntary Exclusion Program and Sports Wagering Exclusion Program statistics for November 2025.

- Chairman Moses asked if there are any differences in what Mr. Rogers does now and what he will need to do once Gilley's opens up because it is parimutuel. Mr. Rogers responded that his understanding is that Gilley's will have their own responsible gambling program and will not participate in the voluntary exclusion program. Chairman Moses asked if that is by statute, regulation, or another method. Mr. Rogers explained that he believes it is by statute.

Director of Gambling DJ Lopez reported:

- As you have heard from Mr. Watkins, Gilley's continues making its final preparations for the grand opening on December 15.
- KRGC staff have now moved into our permanent office.
- Over the last several days KRGC staff have been busy with HHR Terminal/Server Inspections and testing, which is a very involved

process and includes testing: software, pay table set up, percentage review, alarm system and (186) coin test along with Ticket in Ticket out verification.

- As of today, 1000 terminals/servers have been inspected and tested. Also, over 300 + occupational disclosures have been processed and currently working through the background process. We have also added a number of pari-mutual wagering suppliers along with their management and those backgrounds continue through the process as well. With the addition of Sports Wagering and the HHR Facility we have gone from approximately 2500 active individual licenses to around 3000.
- Recognized the KRGC Staff not only of Gilley's but of the entire agency as everyone has had a hand in this process and for their tireless work, the last few months and days during have been very intense.
- There is not much to report on Eureka Downs, DJ spoke with GM Michael Weiss and he has indicated they now have a cost analysis for the track surface work and he is working with Greenwood County Fair Association on the best path forward. Progress is a little slower than anticipated.
- Regarding the breed registry, we are at 175 total registrations, up 25 from last month.
- Chairman Moses mentioned having seen photos of the machines at Gilley's and said that by glancing at the machines he does not see anything that looks like a horse race, rather that they look like the machines at the other facilities. Director Lopez explained that the machines have multiple themes and that the themes can be changed quickly. Chairman Moses asked if the facility will also be doing simulcast. Director Lopez confirmed that there will be simulcast horse races on the second floor. Chairman Moses asked if those are live races. Director Lopez confirmed that they are live races with contracted tracks.

Director of Administration, Audit, Budget, and Finance Brandi White reported:

- Unlike with the KELA facilities, KRGC will take the place of Lottery when it comes to Gilley's revenue collection. It will be very similar to KELA. The gaming day at Gilley's will end at 6:00a.m. At that time, KRGC will run the system reports, do reconciliation, and determine the amount applicable for the 3% tax, the tax will be deposited by the end of the following day to the State Racing Fund, on the 15th of each month the balance of the State Racing Fund will be transferred out to either the Horse Breeding

Development Fund or the Horse Fair Racing Fund but prior to that transfer there is an analysis by KRGC, the Director of Accounts and Reports, and Division of Budget because the statute has a caveat that the KRGC's commission expenses are first paid from those funds. There will be a bit of a cushion that all three entities agree on built into those expenses. Once that is met monthly, that transfer will happen on the 15th. One-third will go to the Horse Breeding Development Fund and two-thirds will go to Horse Fair Racing Fund. There will not be a transfer to the state revenue funds like there is with KELA.

- Chairman Moses asked if the two recipient funds are administered by state agencies. Director White explained that the Horse Breeding Development Fund is for horses that are on the Kansas-bred registry and for the promotion of live horse racing in Kansas. Those funds are awarded based on the races that are run and the purse monies that go out from those. Chairman Moses asked if those were live races. Director White confirmed they would be live races and that they would predominantly be from Eureka Downs theoretically. The Horse Fair Racing Fund is for county fairs and within the statute there is a breakdown of how the funds can be spent by the county fairs, and the commission will have some oversight of those funds and how those funds will be divvied out. Chairman Moses asked if the county fairs had to have horse racing. Director White confirmed they did, or possibly dog racing. Chairman Moses noted that live racing will take some time to begin so regarding the Horse Breeding Development Fund he asked if those funds would accumulate. Director White confirmed that they would accumulate and that it would be up to the legislature if they wanted to move the funds somewhere else. Chairman Moses asked if the legislature could change the statue to redirect those funds to something that is not related to live horse racing. Director White confirmed if it is the will of the legislature they could do appropriate the money elsewhere.

Executive Director Brownlee reported:

- Echoed the chairman's congratulations to James and noted that James had proven himself in his new position.
- General Counsel James Bain and Illegal Gambling Investigator Joe Crough addressed a group of Kansas City law enforcement officers on illegal gaming machines, providing training on identifying illegal gambling devices and enforcing illegal gambling laws.

- Regarding the question about Gilley's participation in the Voluntary Exclusion Program. The Kansas Expanded Lottery Act has a requirement that the lottery gaming facilities participate in the Voluntary Exclusion Program. The Kansas Parimutuel Racing Act, which the Gilley's facility falls under, does not have that requirement. That said, Gilley's has chosen to create their own version of a voluntary exclusion program even though the Kansas Parimutuel Racing Act does not require that.
 - Commissioner Turnquist asked if Gilley's voluntary exclusion program would be presented to the Executive Director or commissioners for review or will it strictly be their decision making. Executive Director Brownlee said that the KRGC would have the ability to review and approve it.
- Regarding the historical horse racing machines, the Executive Director explained that if the Chairman's question was why he did not see the end of a horse race on the machine that is because it appears as a narrow strip across the top of the video board as the video machine does its slot performance. Quite frankly you have to be looking for it. Chairman Moses noted that he believes that there will be some questions for the commission about how similar the historical horse racing machines appear to the machines at the lottery gaming facilities and that the commission will be prepared to answer those questions. Executive Director Brownlee explained that the patron could play the historical horse racing machine in a similar fashion to a slot machine but that there is also the option to place parimutuel wager, the reality is that over 99% of players will not do that.
- Once the lottery gaming facilities are no longer able to stock pennies they will be rounding up to the nearest nickel to the benefit of the patron. Currently, patrons will need to get their loose change to the cage. The Lottery is working with the lottery gaming facilities to donate those odd cents to charities while on the gaming floor. They are currently testing this. The Lottery will have approval over which charities will be acceptable. This process is being used in a number of jurisdictions.
- Last month Commissioner Haag asked if KRGC had been asked to testify in the legislative budget process and Executive Director Brownlee said they had not. This month KRGC was asked to testify. The KRGC budget was presented to the legislative budget committee this week. Director White represented KRGC at the hearing. The budget was presented and there were no questions or discussion.
- Senior staff have been working down at the Gilley's facility for the last two to three weeks. Being on site has proven to be much more

expedient regarding final questions and comments about what can, or should, be done. Executive Director Brownlee shared his appreciation for staff's commitment to being onsite before the facility opens.

- The next commission meeting is scheduled for January 16th at 10:00a.m. in Park City.

Employees

During the 2nd half of 2025, Kansas Star Casino processed 104 new team members through new hire orientation. All received the following training courses as part of orientation:

- Responsible Gaming with special emphasis on underage awareness and an overview of the Voluntary Exclusion Program
- Alcohol Awareness

In addition, team members are subject to a more intensive alcohol awareness training program called, ServSafe. Team members that are trained includes:

- All Front of House Food and Beverage managers and team members that participate in the serving of alcoholic beverages.
- All Security Staff
- All Valet Staff
- Slot Floorperson and above
- Table Games Dealers and above
- Surveillance Staff
- All Directors

ServSafe is a three-hour course with a test at the end which team members must pass with at least a 75% score. In the 2nd half of 2025, 81 team members took and passed the ServSafe training, and 0 team members failed and were required to re-take the training until they received a passing score.

All training is done online with website 360training.com.

The Kansas Star Casino Responsible Gaming trainers are:

- Alecia Pray, Director of Human Resources
- Miranda Fields, Human Resources Manager
- Marlene Rivera, Senior Human Resources Specialist

As of December 31, 2025, Kansas Star Casino had 581 active team members.



Ongoing Training

In addition to the training given in new hire orientation, all Kansas Star Casino team members undergo annual refresher training in Responsible Gaming. To make training more accessible we have the Responsible Gaming training module online in our suite of Skillsoft courses.

The total amount spent on responsible gaming materials was \$681.10, which was spent on ServSafe training, online services.

Daily Application

While all departments and team members are actively involved in preventing underage, intoxicated and self-excluded patrons from entering the casino floor and from gambling if they do gain access, the Security Officers stationed at the gated entrances are the primary method of prevention. Security follows the property's policy of checking IDs for people who appear 30 or younger; the statistics for these ID checks during the 2nd half of 2025 are:

- Underage individuals denied gaming floor access: 149
- People denied access for not having ID: 320
- People denied for invalid ID: 345
- Intoxicated individuals denied gaming floor access: 112
- VEPs denied access to the gaming floor: 11

Further, there were 342intoxicated individuals ejected from the casino, 13 VEPs were removed and turned over to the KRGC and the Mulvane Police Department, and 4 underage person were caught and ejected from the casino. Also, 189 persons were removed and 52 excluded from the casino for a variety of reasons.

During the 2nd half of 2025, there were 619,570guests who entered the casino floor. Security team members checked 86,671 IDs. In addition, 69 ID checks took place on the gaming floor in situations involving suspected minors.

July 1, 2025 thru December 31, 2025

1. Employees

At the end of the reporting period, Hollywood Casino had a total of 511 employees. During the reporting period, 117 employees were hired.

2. Responsible Gaming Training:

All employees hired during the reporting period received initial training on responsible gaming during property orientation. This consisted of approximately 30 minutes dedicated to responsible gaming. All employees successfully completed this training.

Of those new hires, 32 were hired into positions which require additional training to understand the proper procedures for responsible alcohol service. All of those employees successfully completed the TiPS training.

In addition, there were 18 existing employees who successfully completed refresher TiPS training and 7 employees that transferred into new positions that required them to be TiPS certified.

3. Statistics:

To assist in tracking the success of the Responsible Gaming Plan, Hollywood Casino maintains statistics related to responsible gaming. Some of the numbers from the reporting period include:

- Hollywood Casino refused entry to 54 minors who attempted to gain access to the property.
- There was 1 minor who successfully gained access to the casino during the period.
- In addition, Hollywood Casino either refused entry to or removed 275 individuals from the property who appeared to be under the influence of alcohol.
- In addition to training officers to be observant at the casino entrances, Hollywood Casino has procedures in place to identify VEPs when they attempt to cash a check, perform a cash advance, attempt to claim a taxable jackpot, or attempt to create a Penn Play (player club) account. During the reporting period, Hollywood Casino discovered 7 VEPs on property. The local KRGC Agent on Duty was contacted immediately in each of these instances and took custody of the VEP for processing.




Voluntary Exclusion Report

Total Number of Exclusions




Age of SWEP




Active Sports Wagering Exclusion Durations



SWE Enrollment by Platform*







SPORTS WAGERING EXCLUSION ENROLLMENT BY MONTH



To ensure that it is being consistent and efficient, the commission has requested quarterly updates on out-of-state travel, licensing matters, and illegal gambling efforts.

I. OUT-OF-STATE TRAVEL

The quarterly out-of-state travel report includes the employees who traveled and the purpose of the trip and the total expenses incurred for the trip. Because the Commission maintains its background investigation details as highly confidential, the quarterly travel report does not include out-of-state trips for investigative or targeted purposes.

II. LICENSING

Objectives of the commission include conducting timely, but thorough, background investigations on all gaming employees, management contractors, manufacturers and distributors seeking licensure at lottery gaming facilities located in this state. Background investigations are conducted to protect the public interest by maintaining a legitimate and viable gaming industry assuring honesty, good character and integrity of racing and gaming facility operators, employees, and vendors. 
III. ILLEGAL GAMBLING

The Kansas Racing and Gaming Commission (KRGC) provides resources and assistance to local law enforcement, prosecutors, and the public on illegal gambling questions, education, and complaints. The KRGC responds to email and phone complaints and inquiries, conducts continuing legal education seminars for prosecutors, assists local law enforcement agencies with illegal gambling investigations, and conducts civil seizures of illegal gambling devices for forfeiture, all in an effort to curtail illegal gambling in bars, restaurants, convenience stores, and other venues throughout Kansas.

Since 2008, the Commission has received 2,792 total illegal gambling-related questions or complaints from the general public. During the fourth quarter (Q-4) of 2025, the Commission received thirty-five (35) calls or emails from the general public, up five (5) from the previous quarter and up fifteen (15) from the fourth quarter of 2024.

Of the thirty-five (35) calls or emails received in Q-4: thirty-one (31) involved slot machines, one (1) involved raffles, and three (3) involved poker.

Breakdown of illegal gambling inquiries and complaints to-date:



The above chart does not reflect calls and activity related to the following:

- Reports made to KRGC agents by other law enforcement officers around the state.
- Discussions with local law enforcement and district and county attorneys regarding the legal aspects of illegal gambling and the services that KRGC can provide.
- Time spent by agents and legal counsel to assist in active local investigations and prosecutions.
- Time spent defending gambling-related actions against the agency.
- Time spent pursuing seizures and forfeitures of illegal gambling devices.

- Inquiries from the public that are answered through access to KRGC's Illegal Gambling Frequently Asked Questions (FAQs) web page.

KRGC updated the Illegal Gambling FAQs portion of the webpage in late January 2014. Since KRGC began tracking the new page, there have been a total of 30,584 unique page views (after adjustments). A total of 931 unique page views were made during the fourth quarter of 2025, up 354 from the previous quarter (adjusted) and up 143 from the fourth quarter of 2025 (adjusted).
